BUSINESS DESCRIPTION

Christopher's Books is an independent, community-based bookstore selling new books from many genres. It also sells games, toys, and Potrero Hill T-shirts. It prides itself on its curation and ability to quickly order books for the community it serves.

Before founder Christopher Ellison was a bookseller, he worked for a venture capital firm. After a terrible car accident, he reconsidered his life. He wanted to open a business close to his home on Potrero Hill. His love of books and the lack of a neighborhood bookstore inspired him to start Christopher's Books.

In May 1992, Tee Minot joined Christopher as a business partner. Prior to becoming a business partner, Tee had worked at the MIT Press Bookstore in Massachusetts and at Cover to Cover in Noe Valley. In 1994, Chris left the business to fulfill his dream of owning a dairy farm and move back to New Zealand. Soon after, Allyn Stern joined Tee as a business partner. However, since 1996, Tee Minot has been the sole owner of Christopher's Books.

Christopher's Books has been a neighborhood anchor since its opening. The business fosters an intimate atmosphere, drawing in young families and longtime neighbors, offering treats to local pets, and creating lasting friendships with regular customers. The business has also demonstrated their strong commitment to their neighborhood and their city; they provide internships to young adults interested in books, work with schools to support literacy programs, and partner with the Pritzker Psychiatry building to provide books for their youth wellness program, among other things.

Yes, Christopher's Books has contributed to the history and identity of the Potrero Hill neighborhood and San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- The business is associated with the tradition of independent bookstores.
- The bookstore has been associated with at least two films that tourists regularly ask about: Sweet November and Ant-Man and the Wasp.
- Former United States Representative John Burton has been a lifelong patron.
- Christopher's Books is housed in a c. 1904 Queen Anne mixed-use building. The building is a particularly intact example of a transitional building incorporating both Queen Anne and Classical Revival elements. The business's storefront is particularly intact, including a corner pole, mosaic tile threshold and original wood transom. The property is not listed on a local, state, or federal historic resource registry; however, the building was called out as "appears individually significant" in the Draft Neighborhood Commercial Corridors Survey from 2015.
- There have been a number of features and articles on Christopher's Books, both within and outside the industry. "Yes, San Francisco: We're Still Reading Paper" by The Bold Italic references the importance and the experience of stepping into a bookstore in modern day. The "Best Bookstores in San Francisco" by Culture Trip points out the distinct features of Christopher's Bookstore as being "pet-friendly" and holding "book drives for local charities."
- With regard to racial and social equity, Christopher's Books is an LGBTQ+-owned and woman-owned business. They have demonstrated their commitment to the community in many ways, whether donating books to local shelters and youth wellness programs or coordinating book drives for local schools.

CRITERION 3

Is the applicant committed to maintaining the physical features or traditions that define the business, including craft, culinary, or art forms?

Yes, Christopher's Books is committed to maintaining the physical features and traditions that define the business.

Written Historical Narrative

INTRODUCTION

a. Describe the business. What does it sell or provide?

Christopher's Books is an independent community-based bookstore selling new books on many different subjects. It also sells games, toys, and Potrero Hill T-shirts. It prides itself on its curation and ability to quickly order books for the community it serves.

b. Describe whom the business serves.

The business serves all of San Francisco, with a focus on Potrero Hill and adjacent neighborhoods, including the Bayview, Hunters Point, Mission Bay, Dogpatch, SoMa, Bernal Heights, and the Mission. Demographics are families, young professionals, and anyone who enjoys reading and browsing in a well-curated, independent store.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Curated neighborhood bookstore.

CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

a. Provide a short history of the business, including locations and owners.

Christopher's Books was founded in July 1991 by Christopher Ellison in its present-day location at 1400 18th Street. Before Christopher was a bookseller, he worked for a venture capital firm. After a terrible car accident, he reconsidered his life. He wanted to open a business close to his home on Potrero Hill. His love of books and the lack of a neighborhood bookstore inspired him to start Christopher's Books. Chris built and installed all the fixtures still currently in the store. His wife Mary Ann and their young daughter Claire helped Chris welcome the Potrero Hill community into the store. It soon became a local vibrant meeting place.

In May 1992, Tee Minot became a business partner. Tee met Chris when he was getting the shop ready to open. Tee had recently moved to San Francisco from Massachusetts. On the East Coast, she worked at the MIT Press Bookstore. After her arrival in San Francisco, she worked at Cover to Cover in Noe Valley for two years. After many morning chats while Chris was installing the fixtures, and Tee was recovering from breakfast at Just for You, Chris proposed that they become business partners and run the store together. Tee is married to Lynn Dolce and has two sons, Nicolas and Joseph, both involved with the store over the years. Tee lives on Bernal Hill.

Chris left the business in 1994. Chris and his wife Mary Ann had dreams of owning a dairy farm, and it made sense for them to return to New Zealand to do this. They still have a home in Mill Valley, and Chris is thrilled that Christopher's Books is still open and thriving. He is always open to taking a shift if opportunity allows.

Allyn Stern joined as a business partner when Chris left the business. Allyn was a lawyer working with the U.S. Environmental Protection Agency before switching gears and becoming a partner at the store. Allyn loved running the shop and being an indie bookstore owner, but after two years she had some financial concerns that led her back to working at the EPA.

Tee Minot has been the sole owner since 1996.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1991 to 1992: Christopher Ellison

1992 to 1994: Christopher Ellison; Tee Minot

1994 to 1996: Tee Minot; Allyn Stern

1996 to Present: Tee Minot

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

During the COVID pandemic in 2020, the store was closed to the public, and the staff stayed home during the lockdown. Tee found a way to do curbside pickup for the neighborhood. The community was incredibly supportive, many folks purchasing gift certificates for future use and picking up puzzles and books when they were out running necessary errands. Tee was able to participate in the Paycheck Protection Program to keep payroll for the staff in place.

CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Christopher's Books has been a central part of the 18th Street / Potrero Hill business district since opening in 1991. Its doors have been open to the community seven days a week, providing a well curated selection of books for all ages. It is housed in one of the oldest large Victorians on the Hill, and it features vintage photos from the Potrero Hill archive project on its walls. Over the years, Christopher's Books has become a destination for folks visiting the local restaurants.

The business is an anchor for the community, providing an essential service. Many neighbors stop by daily for the free dog treats that Christopher's provides. The booksellers pride themselves on being an intimate neighborhood institution and providing access to the ideas, culture, and

entertainments that only an independent bookstore can deliver. The bookstore is a draw for young families, providing the vibrant community that keeps folks in the city.

b. Is the business associated with significant people or events, either now or in the past?

The bookstore has been associated with at least two films that tourists regularly ask about: *Sweet November* and *Ant-Man and the Wasp*. In *Sweet November*, Charlize Theron lives above the bookstore. Keanu Reeves was also a lead in Sweet November and spent much of his downtime in the shop, browsing the shelves. The main character in *Ant-Man* was under house arrest in an apartment above the store, and many scenes in the movie were filmed at 18th and Missouri streets, the location of the bookstore.

Former United States Representative John Burton has been a lifelong patron.

Christopher's has participated in the Potrero Hill Festival. Over the years, they have sold books and offered free craft activities for families. The most memorable event was with their landlord, Peter Linenthal, an author and illustrator of more than a dozen children's books. The craft was learning simple bookmaking techniques, giving kids the opportunity to take home a handmade book.

c. How does the business demonstrate its commitment to the community?

Christopher's Books demonstrates its commitment to the community in many ways:

- Being open seven days a week.
- Providing a space for people to gather, browse, and share a love of books.
- Consistently engaging with youth who show a real interest in bookselling, writing, and publishing.
- Providing internships to kids and young adults who have grown up in the store.
- Working with local schools and tutoring programs to support various literacy programs.
- Partnering with Umpqua Bank to create a program called Page Turners. Page Turners featured monthly literary events for children, and featured local Bay Area authors and illustrators.
- Working with the Pritzker Psychiatry building to provide books for their youth wellness program.
- Donating bins of toys and books for the Nancy and Stephen Grand Family House.
- Coordinating book drives for nearby Daniel Webster Elementary School and the Hilltop Pregnant Minors Program.
- Handing out free dog treats to all the dogs on walks in the neighborhoods perhaps 50 or more treats a day.

d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

Aside from being featured in the movies *Sweet November* and *Ant-Man and the Wasp*, Christopher's Books has been referenced extensively in the media, particularly in articles regarding Potrero Hill and San Francisco bookstores. Following are some key media mentions.

e. Has the business ever received any awards, recognition, or political commendations?

Christopher's Books has been recognized by the San Francisco Board of Supervisors and the Potrero Boosters. Former Supervisor Malia Cohen honored Tee Minot during a ceremony honoring small business owners. Tee believes it was during Supervisor Cohen's second tenure on the board. Tee does not have the exact year for the Potrero Boosters award, but it was likely in the mid- to late-2010s. Both awards were in recognition of Christopher's contributions to the Potrero Hill community over the years, and a recognition of Tee's many years as a sole proprietor running an indie bookstore in San Francisco.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

There are only a few retail stores on 18th Street, so if Christopher's had to close it would be a big loss for everyone. A community that has had the same indie bookstore for over 30 years would experience a huge loss. The staff are dear friends with many of their customers. Every neighborhood should have a vibrant and active indie bookstore. Books change lives. Christopher's is also the only bookstore in the Potrero Hill, Dogpatch, Mission Bay, Bayview, and Hunters Point neighborhoods.

CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

Christopher's Books is located in a large Victorian at 18th and Missouri street. It is owned by Peter Linenthal who created and runs the Potrero Hill Archives project. The space that the bookstore has been in since 1991 has housed quite a variety of things: a thrift store, a recycling center, two different florists. Back in the 1920s, it was a pharmacy/drugstore called Wulzens. The original fixtures from that shop are still a central part of Christophers Books and are used to feature books.

The French doors and the black tile are mostly original. The architectural details will be maintained. As mentioned before, the historic photos on the walls will never be taken down.

b. In a few words, describe the main business activity you commit to maintaining.

Christopher's Books is committed to keeping a vibrant independent bookstore open seven days a week offering a well curated selection of books. They are committed to employing new and seasoned booksellers who want to create an atmosphere of openness and curiosity and comfort, an environment that welcomes whoever walks through the door, and any four-legged friend looking for a daily treat.

c. What is the plan to keep the business open in the long term beyond the current ownership?

The current owner is committed to a succession plan with a current staff member who understands what makes Christopher's special and knows the importance of becoming a Legacy Business in San Francisco. Their vision for the future of Christopher's is well grounded in an understanding of what Christopher's has been throughout the years. They grew up in the neighborhood and spent many early days and middle school years at the shop — a true San Franciscan, so of course a diehard Giants fan.

d. What challenges is the business facing today?

Christopher's Books faces the same challenges that many independent retail businesses in San Francisco face today: keeping the neighborhood it resides in a safe and clean and vibrant urban home and destination; providing its employees with wages and benefits that allow them to stay in the city; finding opportunities to partner with other San Francisco cultural institutions that are committed to staying in the city; and having a lease in place that will ensure its future success.








CHRISTOPHER'S BOOKS CELEBRATES 25 YEARS ON POTRERO HILL

Next month, Christopher's Books will turn 25 years old, and for many members of the Potrero Hill community, it will be a birthday worth celebrating.

"It's really a community space that happens to be a bookstore," said owner Tee Minot, who began working there a year after it opened in 1992, and has been the sole proprietor of the shop since 1996.

Minot first met the store's founder and namesake
Christopher Ellison in 1992 as a regular at Just For You
Cafe, when the diner was still located nearby on 18th
Street. Ellison, a former venture capitalist from New
Zealand, had originally opened up shop as a local
resident that wanted to see a small, independent
bookstore in his neighborhood. Although he no longer
holds a stake in the business, Minot reports that he still
picks up a few shifts a month.

"He's one of the nicest guys you'll ever meet, and you can talk to him about anything," she told us.

Minot says the store has always employed an average of about seven people, ranging from folks in their teens to people in their mid-sixties. She's seen many of her customers and employees grow from kids to adults, and attributes a great deal of the store's success to the neighborhood and her staff.

"The store has a great atmosphere. Most of the time we're having a lot of fun while we are working," said Lael Robertson, who has been at Christopher's Books since 2002. She joked that Minot had first offered her a few shifts here and there over the holidays as a respite from running a household with three kids, all of whom would eventually come to work at the shop in some capacity as well.

"Kids grow up in the store," said Minot. "A lot of times, it's the first place they're allowed to walk to alone, and it's where they try to get their first job. It's an extension of my home ... if I could put couches in here, I would."

It's no surprise, then, that Minot and her staff pride themselves on their robust selection of children's books and are also sure to keep a fair amount of toys for sale on hand. Christopher's Books is also known for its selection of fiction titles and cookbooks.



Running a small, independent bookstore in San Francisco has not been without its challenges. Minot's business has seen the rise of Amazon.com and other online sellers since she began working there in the early '90s, a rise that spelled doom for many similar indie bookstores.

"In the beginning, I kept trying to figure out how I could compete with Amazon," said Minot. "However, I realized that I didn't want to be a chain, but a small, well-curated space where people could have a face to face relationship to their bookseller."



Minot has also had to work to remain a relevant community resource to a surrounding area that is changing drastically. Not all that many years ago, the Mission Bay neighborhood was still in its fledgling stages. Now, it's sprung up into a healthcare epicenter, and Minot felt compelled to contribute to those in need.

To this end, Christopher's Books is sponsoring a book drive benefitting The Nancy and Stephen Grand Family House, an organization that provides housing for families of those hospitalized with life-threatening illnesses. They will also assist the new Mission Bay facility in maintaining a library for kids and adults alike.

In the past, Christopher's Books has held similar book drives for nearby Daniel Webster Elementary School and Hilltop Pregnant Minors Program.



As for the Potrero Hill community, Robertson told us that while she has noticed more high-limit, metal credit cards being used at the store, the neighborhood's evolution has neither hurt nor drastically improved sales. "The newer crowd is not spending as much time in the neighborhood they live in," she said.

Minot did report that newer restaurants on 18th Street have helped to bring a newer, younger group of people Christopher's Books Celebrates 25 Years On Potrero Hill

into the store, especially while they wait in invariably long brunch lines.

"I've enjoyed meeting all the people coming to this neighborhood because of Plow. They love the bookstore. I think people in their twenties are having a reaction to all the technology that surrounds them, and walking into a bookstore is sort of a quaint, retro experience," said Minot.

Business Description

Christopher's Books is an independent, community-based bookstore selling new books from many genres. It also sells games, toys, and Potrero Hill T-shirts. It prides itself on its curation and ability to quickly order books for the community it serves. Before Christopher was a bookseller, he worked for a venture capital firm. After a terrible car accident, he reconsidered his life. He wanted to open a business close to his home on Potrero Hill. His love of books and the lack of a neighborhood bookstore inspired him to start Christopher's Books.

In May 1992, Tee Minot joined Chrisopher as a business partner. Prior to becoming a business partner, Tee had worked at the MIT Press Bookstore in Massachusetts and at Cover to Cover in Noe Valley. In 1994, Chris left the business to fulfill his dream of owning a dairy farm and move back to New Zealand. Soon after, Allyn Stern joined Tee as a business partner. However, since 1996, Tee Minot has been the sole owner of Christopher's Books.

Christopher's Books has been a neighborhood anchor since its opening. The business fosters an intimate atmosphere, drawing in young families and longtime neighbors, offering treats to local pets, and creating lasting friendships with regular customers. The business has also demonstrated their strong commitment to their neighborhood and their city; they provide internships to young adults interested in books, work with schools to support literacy programs, and partner with the Pritzker Psychiatry building to provide books for their youth wellness program, among other things.

Staff Analysis

Review Criteria

1. When was business founded?

The business was founded in 1991.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Christopher's Books qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Christopher's Books has operated continuously in San Francisco for 33 years.
- b. Christopher's Books has contributed to the history and identity of the Potrero Hill neighborhood and San Francisco.
- c. Christopher's Books is committed to maintaining the physical features and traditions that define the organization.

3. Is the business associated with a culturally significant art / craft / cuisine / tradition?

Yes. The business is associated with the tradition of independent bookstores.

4. Is the business or its building associated with significant events, persons, and / or architecture?

Yes. The bookstore has been associated with at least two films that tourists regularly ask about: Sweet November and Ant-Man and the Wasp.. Former United States Representative John Burton has also been a lifelong patron. Additionally, Christopher's Books is housed in a c. 1904 Queen Anne mixed-use building. The building is a particularly intact example of a transitional building incorporating both Queen Anne and Classical Revival elements. The business's storefront is particularly intact, including a corner pole, mosaic tile threshold and original wood transom.

5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

No. However, the building was called out as "Appears individually significant" in the Draft Neighborhood Commercial Corridors Survey from 2015.

6. Is the business mentioned in a local historic context statement?

No, not as of the date of this Executive Summary.



7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. There have been a number of features and articles on Christopher's Books, both within and outside the industry. "Yes, San Francisco: We're Still Reading Paper" by *The Bold Italic* references the importance and the experience of stepping into a bookstore in modern day. The "Best Bookstores in San Francisco" by *Culture Trip* points out the distinct features of Christopher's Bookstore as being "pet-friendly" and holding "book drives for local charities."

Racial and Social Equity Analysis

On July 15th, 2020 the San Francisco Historic Preservation Commission adopted <u>Resolution No. 1127</u> centering Preservation Planning on racial and social equity. Understanding the benefits, burdens, and opportunities to advance racial and social equity that proposed Preservation Planning documents provide is part of the Department's Racial and Social Equity Initiative. This is also consistent with the Mayor's Citywide Strategic Initiatives for equity and accountability and with the Office of Racial Equity, which required all Departments to conduct this analysis.

The Legacy Business Program is deeply intertwined with these goals. One of the primary purposes of the Legacy Business Program is to maintain San Francisco's cultural fabric and to foster civic engagement and pride by assisting long-operating businesses remain in the city. The Legacy Business Registry was established to recognize longstanding, community-serving businesses that are valuable cultural assets of the city. These businesses, ranging from restaurants to art galleries to tire shops to community shelters, are key to sustaining the racial and social diversity in San Francisco and adding to the identity and character of our city and the many communities within it.

Christopher's Books is an LGBTQ+-owned and woman-owned business. They have demonstrated their commitment to the community in many ways, whether donating books to local shelters and youth wellness programs or coordinating book drives for local schools.
