#### **BUSINESS DESCRIPTION**

Gallery 444 was founded by Bettie Mitchell and her daughter Desireé Mitchell on August 1, 1993. Located at 444 Post Street in San Francisco's historic Union Square, Gallery 444 is a women-owned and -operated gallery that sells original fine art by over 20 local and international artists. The gallery provides food for the soul with vibrant, colorful creations by a diverse group of artists not found anywhere else. Gallery 444 offers no giclée or other forms of reproductions, showcasing only original prints, paintings, and sculpture.

Bettie originally worked at Cory Galleries prior to opening her first gallery City Gallery at the St. Francis in 1980. City Gallery at the St. Francis was located on Geary Street, but closed in 1992, the year before Bettie and Desireé opened Gallery 444. Desireé's sister, Heidi Bass, joined Gallery 444 in 1995 and worked as the director and sales manager until she retired in 2014. Heidi is still very active on the board of directors and serves as a trusted advisor, mentor, and part owner. Since Bettie's passing in 2013, Desireé continues to run the gallery, which still exists in its original Union Square location.

Gallery 444 is a necessary stop on any San Francisco gallery tour for all San Franciscans, Bay Area residents, Californians, and international travelers.

Yes, Galley 444 has contributed to the history and identity of the Union Square neighborhood and San Francisco.

- The business is associated with the curation and enjoyment of art, showcasing only original prints, paintings, and sculptures.
- Gallery 444 features an extensive selection of early and recent works by internationally
  distinguished and beloved Bolivian painter Graciela Rodo Boulanger, including original oils,
  collages, watercolors, etchings, and lithographs. In addition, the gallery elegantly displays a
  unique collection of exciting original works by important contemporary artists such as
  surrealist master Rafal Olbinski and pop art star Jisbar. Gallery 444 is also the exclusive
  representative of the brilliant Peruvian artist Rossmary Valverde.
- Well known patrons of Gallery 444 include Cindy Williams, Tom Snyder, Robin Williams, and Shari Belafonte.
- The building that houses Gallery 444, known as the Chamberlain Building, was designed by Authur Brown Jr., who is well-known for his monumental works throughout San Francisco and the greater Bay Area. The site is a contributor to the Article 11 Kearny-Market-Mason-Sutter Conservation District. The building was called out as a "Category I-Significant Building, No Alterations." The property has been evaluated in several surveys including the Foundation for San Francisco Heritage (1978), in which it was identified to be of major importance, and the Department of City Planning 1976 survey, where it was rated 4 out of 5 (with 5 as the highest rating for architecture). Further, the building appears eligible for the National Register as an individual property through survey evaluation.

- With regard to racial and social equity, Gallery 444 has been women-owned and -operated since its establishment in 1993. The business is community oriented and has been a popular location for hosting benefit events that contribute to a variety of local and national nonprofit organizations and has long supported prominent charities such as San Francisco General Hospital Foundation, San Francisco Giants Community Fund, San Francisco Chronicle's Season of Sharing, and San Francisco SPCA. As the neighborhood's identity has shifted over the last decades, Gallery has remained a unique artistic pillar of the community.

#### **CRITERION 3**

Is the applicant committed to maintaining the physical features or traditions that define the business, including craft, culinary, or art forms?

Yes, Galley 444 is committed to maintaining the physical features and traditions that define the business.

#### a. Describe the business. What does it sell or provide?

Located at 444 Post Street in San Francisco's historic Union Square, Gallery 444 is a family owned and operated gallery that sells original fine art by over 20 local and international artists. They provide vibrant, colorful creations by a diverse group of amazing artists found no place else. Gallery 444 offers no giclée or other forms of reproductions, showcasing only original prints, paintings, and sculpture.

#### b. Describe whom the business serves.

Gallery 444 is a necessary stop on any San Francisco gallery tour. Gallery 444's customers include San Franciscans, Bay Area residents, Californians, and international travelers from across the globe.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Providing food for the soul with original fine art.

## CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

a. Provide a short history of the business, including locations and owners.

Gallery 444 was founded by Bettie Mitchell and her daughter Desireé Mitchell at 444 Post Street on August 1, 1993. Bettie originally worked at Cory Galleries prior to opening her first gallery "City Gallery at the St. Francis" in 1980. That gallery was on Geary Street and that business closed in 1992, the year before Bettie and Desireé opened Gallery 444.

Desireé's sister Heidi Bass joined the business in 1995 and worked as the director and sales manager until 2014 when she had to retire due to health issues. She is still on the board of directors and serves as a trusted advisor and mentor.

Bettie passed away in 2013. Desireé continues to run the gallery, which still exists in its original Union Square location. Heidi still owns a small percentage of the company.

#### b. Provide the ownership history of the business in a consolidated year-to-year format.

1993 to 1995: Bettie Mitchell; Desireé Mitchell

1995 to 2013: Bettie Mitchell; Desireé Mitchell; Heidi Bass

2013 to Present: Desireé Mitchell; Heidi Bass

## c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

The only time the gallery shut down was during the COVID-19 pandemic from March 16, 2020, until mid-September 2020. During that time, however, the gallery still provided much needed art remotely during the height of the pandemic, including a couple of "drive by" sales to local clients.

## CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Gallery 444 is likely the oldest surviving gallery in Union Square, and one of the oldest in the greater downtown area. The gallery has relationships with many of their neighbors and neighborhood businesses. The gallery makes their block look great. San Francisco is historically an artful city, and Gallery 444 has been a part of San Francisco's artistic fabric and has been brightening Post Street since 1993. The business is a destination for many repeat visitors.

#### b. Is the business associated with significant people or events, either now or in the past?

Gallery 444 carries several important artists. They feature an extensive selection of early and recent works by internationally distinguished and beloved Bolivian painter Graciela Rodo Boulanger, including original oils, collages, watercolors, etchings, and lithographs. In addition, the gallery elegantly displays a unique collection of exciting original works by important contemporary artists such as surrealist master Rafal Olbinski and pop art star Jisbar. Gallery 444 is also the exclusive representative of the brilliant Peruvian artist Rossmary Valverde.

Galllery 444 has several famous clients as well. The business generally does not publish names of their well-known clients, and some are also no longer with us. However, the list includes Cindy Williams, Tom Snyder, Robin Williams, and Shari Belafonte. All of the clients at Gallery 444 are significant; some clients are just more well-known than others.

#### c. How does the business demonstrate its commitment to the community?

Gallery 444 has a long history of hosting special events to benefit local and non-local charities, including San Francisco General Hospital Foundation, San Francisco SPCA, The Chronicle's Season of Sharing, San Francisco Giants Community Fund, WildAid, and the Lorraine Hansberry Theater.

#### e. Has the business ever received any awards, recognition, or political commendations?

Gallery 444 has yet to receive any official awards or political commendations.

## f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If Gallery 444 were to close, San Francisco would lose a unique place in the art world. The city would miss the colorful and uplifting oasis – a place to find food for the soul. In addition, the gallery's employees would have to find other employment, and the space may become another empty Union Square storefront. Gallery 444's loyal and loving clients from around the world would be disappointed if they were not there, as many come to visit whenever they are in town.

## CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

The gallery is committed to maintaining a clean, graffiti-free marble front on the historic building.

b. In a few words, describe the main business activity you commit to maintaining.

Art for all to enjoy and for collectors to appreciate in their homes or offices every day.

c. What is the plan to keep the business open in the long term beyond the current ownership?

As a family owned and operated business since 1993, the current ownership hopes to pass down the legacy of Gallery 444 to another generation. The gallery will never sell out to any large corporation.

d. What challenges is the business facing today?

The challenges of maintaining a business, especially in the current climate of Union Square are well known. The mentally ill and those under the influence of drugs often scare off many of the visiting customers and travelers. The economy is never certain; however, the increased police presence in the area since the smash-and-grab incidents of 2021 has been welcome.



The Planning Department Historic Resource Status of the building at 442-444 Post Street is "A - Historic Resource Present." The Chamberlain Building, constructed in 1925, is a "significant building" of "major importance" per the Planning Department. It appears eligible for the National Register as an individual property through survey evaluation. It is also a contributor to the Kearny-Market-Mason-Sutter Conservation District.

## **Gallery 444**

Real estate in San Francisco's historic Union Square is expensive to say the least, so it's a credit to Gallery 444 that the family-operated space has stood strong at the same Post Street location since 1993. The modest-yet-inviting fine art space features works like Marty Goldstein's endearing bronze canine sculptures, French mixed-media pop art provocateur Jisbar's large-scale canvases and Bolivian painter Graciela Rodo Boulanger's famed depictions of cherubic-faced children. It's a worthy stopover when you need a break from the commercial inundation of Union Square.

### When you think of the ultimate Dynamic Woman, what do you think of?

#### What sets you apart in your industry?

We exhibit only original art from both local and international artists. Our walls are always alive with color. #### Tell us about your philanthropic efforts.

#### **Business Description**

Gallery 444 was founded by Bettie Mitchell and her daughter Desireé Mitchell on August 1, 1993. Located at 444 Post Street in San Francisco's historic Union Square, Gallery 444 is a women-owned and operated gallery that sells original fine art by over 20 local and international artists. The gallery provides food for the soul with vibrant, colorful creations by a diverse group of artists not found anywhere else. Gallery 444 offers no giclée or other forms of reproductions, showcasing only original prints, paintings, and sculpture. Gallery 444 is a necessary stop on any San Francisco gallery tour for all San Franciscans, Bay Area residents, Californians, and international travelers.

Bettie originally worked at Cory Galleries prior to opening her first gallery "City Gallery at the St. Francis" in 1980. City Gallery at the St. Francis was located on Geary Street, but closed in 1992, the year before Bettie and Desireé opened Gallery 444. Desireé's sister, Heidi Bass, joined Gallery 444 in 1995 and worked as the director and sales manager until she retired in 2014. Heidi is still very active on the board of directors and serves as a trusted advisor,

mentor, and part owner. Since Bettie's passing in 2013, Desireé continues to run the gallery, which still exists in its original Union Square location.

#### **Staff Analysis**

#### **Review Criteria**

#### 1. When was business founded?

The business was founded in 1993.

#### 2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Galley 444 qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Galley 444 has operated continuously in San Francisco for 31 years.
- b. Galley 444 has contributed to the history and identity of the Downtown/Civic Center neighborhood and San Francisco.
- c. Galley 444 is committed to maintaining the physical features and traditions that define the organization.

#### 3. Is the business associated with a culturally significant art / craft / cuisine / tradition?

Yes. The business is associated with the curation and enjoyment of art, showcasing only original prints, paintings, and sculptures.

#### 4. Is the business or its building associated with significant events, persons, and / or architecture?

Yes. Gallery 444 features an extensive selection of early and recent works by internationally distinguished and beloved Bolivian painter Graciela Rodo Boulanger, including original oils, collages, watercolors, etchings, and lithographs. In addition, the gallery elegantly displays a unique collection of exciting original works by important contemporary artists such as surrealist master Rafal Olbinski and pop art star Jisbar. Gallery 444 is also the exclusive representative of the brilliant Peruvian artist Rossmary Valverde. Well known patrons of Gallery 444 include Cindy Williams, Tom Snyder, Robin Williams, and Shari Belafonte.

The building, known as the Chamberlain Building, was designed by Authur Brown Jr., who is well-known for their monumental works throughout San Franciso and the greater Bay Area.

#### 5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

Yes, the site is a contributor to the Article 11 Kearny-Market-Mason-Sutter Conservation District. The building was called out as a "Category I - Significant Building, No Alterations." The property has been evaluated in several surveys including the Foundation for San Francisco Heritage (1978), in which it was identified to be of major importance, and the Department of City Planning 1976 survey, where it was rated 4 out of 5 (with 5 as the highest rating for architecture). Further, the building appears eligible for the National Register as an individual property through survey evaluation.



#### 6. Is the business mentioned in a local historic context statement?

No, not as of the date of this Executive Summary.

#### 7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. There have been a number of features and articles on Gallery 444, both within and outside the industry, including articles by: San Francisco Magazine "10 Museums And Exhibitions To Explore In The Bay Area This Winter"; Artnet "Artist Helmut Koller's Vibrant Animal Paintings Can Instantly Cure the Winter Blues—See Them Here"; and Inside Hook "9 San Francisco Art Galleries to Visit Right Now".

#### **Racial and Social Equity Analysis**

On July 15<sup>th</sup>, 2020 the San Francisco Historic Preservation Commission adopted <u>Resolution No. 1127</u> centering Preservation Planning on racial and social equity. Understanding the benefits, burdens, and opportunities to advance racial and social equity that proposed Preservation Planning documents provide is part of the Department's Racial and Social Equity Initiative. This is also consistent with the Mayor's Citywide Strategic Initiatives for equity and accountability and with the Office of Racial Equity, which required all Departments to conduct this analysis.

The Legacy Business Program is deeply intertwined with these goals. One of the primary purposes of the Legacy Business Program is to maintain San Francisco's cultural fabric and to foster civic engagement and pride by assisting long-operating businesses remain in the city. The Legacy Business Registry was established to recognize longstanding, community-serving businesses that are valuable cultural assets of the city. These businesses, ranging from restaurants to art galleries to tire shops to community shelters, are key to sustaining the racial and social diversity in San Francisco and adding to the identity and character of our city and the many communities within it

Gallery 444 has been women-owned and operated since its establishment in 1993. The business is community-oriented and has been a popular location for hosting benefit events that contribute to a variety of local and national nonprofit organizations and has long supported prominent charities such as San Francisco General Hospital Foundation, San Francisco Giants Community Fund, San Francisco Chronicle's Season of Sharing, and San Francisco SPCA. As the neighborhood's identity has shifted over the last decades, Gallery has remained a unique artistic pillar of the community.
