BUSINESS DESCRIPTION

Inspired by famous cafés in North Beach and seeing the need for a neighborhood café in the Outer Sunset, Patrick Maguire opened Java Beach Café in 1993. Patrick took over the long vacant space at 1396 La Playa Street and renovated it. Impressed by the renovations and the business proposal, landlord Mr. Chan gave Patrick one year of free rent. It was only a few years later in 1999 that Patrick purchased the building from Mr. Chan. Patrick opened a second location at 2650 Sloat Blvd. in 2008 which is located directly across from the San Francisco Zoo. In 2021, Buffy Maguire became a 51 percent owner of Java Beach Café.

Today, Java Beach is known as a San Francisco institution. They serve a variety of coffee and tea drinks, as well as pastries, sandwiches, soups, and salads. All of their coffee is freshly roasted by their team in the San Francisco Bay Area. In fact, they were the first café to serve locally roasted, fair-trade coffee in the Outer Sunset. Locals from the neighborhood, as well as tourists visiting the nearby Ocean Beach, patronize the business regularly. The owners describe the business as a “second home to many and a friend’s living room to others.”

Java Beach gives back to the community they serve. The owners and their staff helped start Neighborhood Watch within the community, sponsored surf contests, helped construct a bocce ball court, supported the creation of public art sculptures on Judah Street, and started a Merchant Association.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- Café's are culturally significant for the craft of coffee. Café's also have a long tradition for being communal gathering places such as being unofficial town halls, spaces for artists to showcase their craft, and as places to work.
- Java Beach Café has been featured in SFGate, Eater SF, 7x7, Hyperflyer, The Bold Italic, Timeout, San Francisco Magazine, The San Francisco Chronicle, and Hoodline.
- Java Beach Café has won numerous awards, including the following:
 - San Francisco Beautification Award for work done to the La Playa Pocket Park in 2009
 - Certificate of Honor from the Board of Supervisors in 2010, 2014, 2017 and 2019
 - Gellert Family Business Award from University of San Francisco in 2014
 - Multiple Certificates of Recognition from politicians in 2017 including Assemblymember Tom Ammiano, Assemblymember Phillip Ting, Congresswoman Nancy Pelosi, and Congresswoman Jackie Speier.
- With regard to racial and social equity, Java Beach Café is a woman-owned business with Buffy Maguire having 51 percent ownership in the business. Additionally, Java Beach Café has demonstrated their commitment to their community and neighborhood through sponsoring surf contests, helping to install public art, and starting the Neighborhood Watch and Merchant Association, among other things.

CRITERION 3

Written Historical Narrative

INTRODUCTION

a. Describe the business. What does it sell or provide?

Java Beach Café serves a variety of coffee and tea drinks, pastries and other breakfast items, soup salads, sandwiches, and subs. A San Francisco institution, Java Beach Café has been serving homemade and locally sourced eats for decades. All of their coffee is freshly roasted by their team in the San Francisco Bay Area and brought right to their cafés so that they can serve you the perfect cup every single morning.

b. Describe whom the business serves.

The business serves the Sunset/Outer Sunset/Ocean Beach neighborhood communities with its two locations – on Sloat Blvd at the Zoo and on 44th and Kirkham, across from the Great Highway and Ocean Beach. Their proximity to the beach also brings in tourists and people from other neighborhoods.

The customers of Java Beach Café are anyone who live in the neighborhood – all genders and ages. Because of its longevity in the two neighborhoods it serves, it has become a meeting place where neighbors and friends get together to catch up and share a cup of coffee or casual meal.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

They treat you like family.

CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

a. Provide a short history of the business, including locations and owners.

In 1993, Patrick Maguire had a vision and thought, “Why do you have to get in your car to get a great cup of coffee?” A native San Franciscan, Patrick had been inspired by the cafés he saw in North Beach and wanted to create a café in his Outer Sunset neighborhood that would become a welcoming beacon to all who lived there. He saw a building at 1396 La Playa Street that had been vacant for years and approached the owner, Mr. Chan, and asked if he could renovate the building to make a small café. No money exchanged hands. In fact, Mr. Chan gave Patrick free rent for a year once he saw what a beautiful job of renovation Patrick and his neighborhood buddies were doing. The café opened on March 20, 1993, and proved to be a neighborhood haven where friends and families gather regularly.

In 1999, Patrick bought the building from Mr. Chan.

Java Beach Café opened a second location located at 2650 Sloat Blvd. across from the San Francisco Zoo on October 8, 2008. With the second location, the business is at the bookends of the Sunset. The 2650 Sloat Blvd. location was at the original entrance to the SF Zoo and formerly housed a hamburger spot to serve those zoo goers. In later years, it became a dilapidated bar called the 49 Club.

In 2021, Buffy Maguire became a 51 percent owner in the business. Over the years, the leadership team at Java Beach became a group of incredible women led by Buffy. Eventually, Pat and Buffy decided to reflect that in their ownership.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1993 to 2021: Patrick Maguire
2021 to Present: Patrick Maguire and Buffy Maguire

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

Java Beach Café has not ceased operations at all since it began. During the COVID pandemic, they remained open as an “essential business” and never closed.

CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Java Beach Café started with one simple question: Why should neighbors have to take a road trip out of the neighborhood for a good cup of coffee? The foundation of Java Beach has always been a commitment to serving superb coffee. All of their coffee is locally roasted, and it is all organic, sustainable, and fair trade. Java Beach Café was the first café to serve locally roasted fair-trade coffee in the Outer Sunset.

The business has become a hub of neighborhood activities. The owners and their staff helped start Neighborhood Watch within the community, sponsored surf contests, helped construct a bocce ball court, were vital in getting a grant from the city for public art for the Judah Street sculptures, and started a Merchant Association.

Forever a work in progress, Java Beach Café is the love and life work of Patrick and Buffy Maguire. Java Beach is more than a coffee shop; it is a second home to many and a friend's living room to others. Many relationships and marriages began at Java Beach and now the

second generation of Java Beach customers are tall enough to order their own drinks and, sometimes, old enough to pay for them!

Java Beach Café has evolved over the years, but the spirit of hope and possibility that manifested itself on that fateful day in October 1993 remains alive and is part of the magic at the edge of the world where Java Beach is perched on the Pacific Ocean. In short, Java Beach was started with a briefcase of nothing but chutzpah, and all these years later it has become the embodiment of “be bold and great forces will come to your aid.”

b. Is the business associated with significant people or events, either now or in the past?

In 1993, when Patrick Maguire was 25 years old, he was recognized as being the youngest business owner in the city by the San Francisco Chronicle. Patrick’s recognition from the Chronicle brought notoriety to all of the Outer Sunset. You might consider him to be a local celebrity.

c. How does the business demonstrate its commitment to the community?

Java Beach Café and the Maguire family have helped the Sunset District tremendously.

“Over the years, the café and its staff have been involved in several neighborhood projects. The Maguires played a leading role in a community effort to clean up the area between La Playa Street and the Great Highway and turn it into a park. ... Other projects have included beach clean-ups, Thanksgiving dinners for local homeless people, and maintenance of the public areas surrounding the Great Highway.”¹

They also started a Neighborhood Watch program as well as a Merchant Association for Judah Street merchants, and they spearheaded a request for an art beautification grant.

e. Has the business ever received any awards, recognition, or political commendations?

For more than 25 years, Pat and Buffy McGuire have provided a welcoming and cozy neighborhood hangout for locals and visitors alike to experience San Francisco’s beach culture. Your involvement in your community through the formation of a merchant’s association for Judah Street, as well as the leadership you have provided on many neighborhood projects demonstrates your love for and commitment to our City. Your tireless efforts to build a community business have resulted in improving the vitality of the surrounding neighborhood, also providing many with the opportunity for employment and personal growth. From your two beloved locations, to your locally roasted beans and the Lady Falcon Coffee Club, you have demonstrated entrepreneurship and a commitment to your community, truly representing San Francisco values at their best.”

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

Java Beach Café is a critical part of the Sunset District and has contributed greatly to the community. Since 1993, they have done so much to help improve the physical appearance of the neighborhood, as well as enhance the lives of the residents. It would be a great loss if the business were to close. Java Beach Café also employs a number of employees, many of whom have worked there for over 10 years.

Java Beach Café is committed to serving excellent coffee and delicious food in a warm, family-like atmosphere.

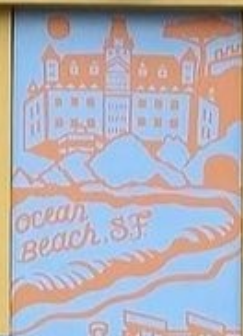

23 YEARS OF JAVA BEACH CAFÉ, AN OUTER SUNSET INSTITUTION

On any given day, the Outer Sunset's [Java Beach Café](#) is likely filled to bursting with patrons, their conversations and clacking cutlery blending into a pleasant ambient hum that can be heard half a block away.

More than a neighborhood institution, the small yellow and blue building is a second home to many local residents, who while away a few hours chatting with friends, listening to music, or simply reading a book as they enjoy their coffee and food.

For owner-managers Buffy and Patrick Maguire, this relaxed atmosphere is a point of pride, something they always intended to cultivate within Java Beach's walls. "[Patrick] always cherished that hangout time that was very much like his mother's living room," said Buffy. "Where they could tell stories and there was no

beginning, middle, or end. In his mother's living room, the front door was always open."

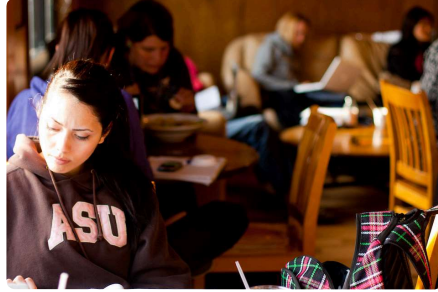

Java Beach was founded 23 years ago, when Patrick, an Outer Sunset native, became increasingly aware of the lack of neighborhood joints in the area. One day, during a regular Ocean Beach outing, he saw a dilapidated building for sale at the corner of Judah and La Playa streets.

"He saw it all, he saw a café, the whole thing," said Buffy. "And he said, 'I'm gonna do it.' So he went home, and he put a suit on, and he grabbed an empty briefcase and came back and rang the doorbell of the landlord. They began a series of long conversations in which they connected very deeply. What resulted was that Mr. Chan gave him the building for a year for free, if he did all the remodeling himself."

With the help of just about all of his friends in the neighborhood, Patrick completed the renovations and got the café up and running on March 20th, 1993. In the years since, Java Beach's offerings have expanded from coffee to a full menu of pastries and lunch items. There's also a second location at [2650 Sloat Blvd.](#), and a sister business called [Beachside Coffee Bar & Kitchen](#), next to the original La Playa store.

Over the years, the café and its staff have been involved in several neighborhood projects. The Maguires played a leading role in a community effort to clean up the area between La Playa Street and the Great Highway and turn it into a park.

According to Buffy, the city was initially opposed, but eventually backed the idea. "One of Pat's favorite lines was, 'If you're going to arrest me for building a park, then go ahead,'" said Buffy. "It was really tense, but we did actually end up getting a lot of city legislators' help."

Other projects have included beach clean-ups, Thanksgiving dinners for local homeless people, and maintenance of the public areas surrounding the Great Highway.

"This is where we live, this is where our family lives, we're in it for the long run—it's just probably not what normal businesses are in it for," said Buffy. "Our neighbors were so supportive, and we're friends with them. Then those neighbors became very, very involved, and they started to take the lead on some projects."

Given its long history, Java Beach has had a large part in driving the growth of the Outer Sunset's business community. "We did a Merchant's Association on Judah Street, and we were really courting businesses to come to Judah Street," said Buffy. "It's now hip. Everyone is really cool, and we're all different sorts of merchants, which is great."

There have even been more than a few love connections sparked at Java Beach over the years. Most of Patrick's brothers met their wives when they were working behind the counter at the café, according to Buffy, who says she has 29 nieces and nephews in the Sunset alone.

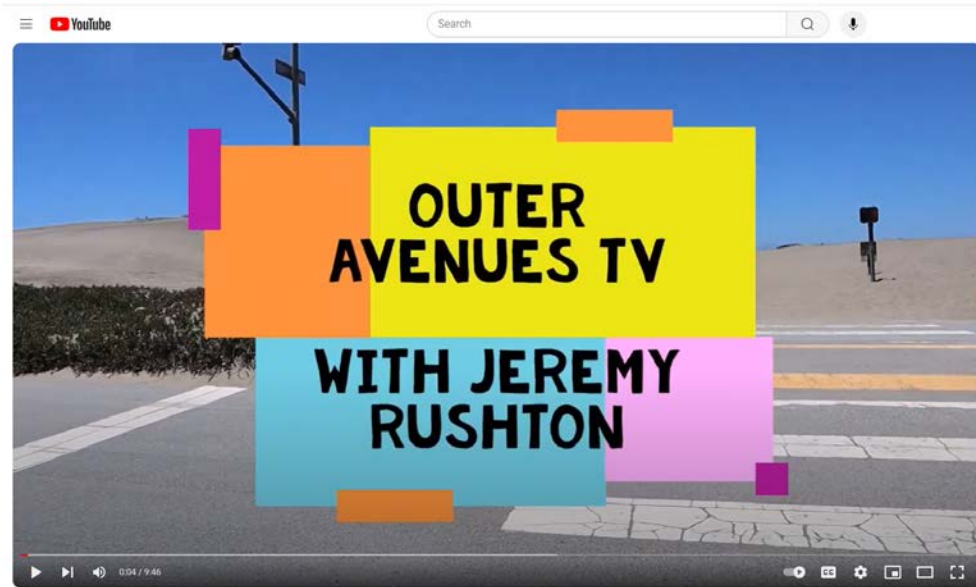
"It's really amazing to be part of a community where people bring their kids here for the first time after the hospital, and then it's the blink of the eye and they're putting their money up on the counter. Fast forward a couple more years and they're applying for a job and they work for you, and then they're going to college," said Buffy. "It's been an amazing life experience to see so many different lives coincide and coexist together."

The cafe isn't done evolving, either. Although Java Beach has always roasted its own coffee, it has begun selling its beans wholesale for the first time. The brand is called [Carville Coffee](#), a nod to [the beachside community's past](#). A Java Beach coffee truck is also in the works, and should debut in the next few months. "We have a 1948 GMC red van that should be ready soon," said Buffy. "We sort of tackle things as the inspiration hits us."

Java Beach Café is located at 1396 La Playa St. Hours are Monday–Friday from 5:30am–11pm, and Saturday–Sunday from 6am–11pm. For more information, visit [their website](#).

Business Description

Inspired by famous cafes in North Beach and seeing the need for a neighborhood café in the Outer Sunset, Patrick Maguire opened Java Beach Café in 1993. Patrick took over the long vacant space at 1396 La Playa St and renovated it. Impressed by the renovations and the business proposal, landlord Mr. Chan gave Patrick one year of free rent. It was only a few years later in 1999 that Patrick purchased the building from Mr. Chan. Patrick opened a second location at 2650 Sloat Blvd in 2008 which is located directly across from the San Francisco Zoo. In 2021, Buffy Maguire became a 51 percent owner of Java Beach Co.

Today, Java Beach is known as a San Francisco institution. They serve a variety of coffee and tea drinks, as well as pastries, sandwiches, soups, and salads. All of their coffee is freshly roasted by their team in the San Francisco Bay Area. In fact, they were the first café to serve locally roasted, fair-trade coffee in the Outer Sunset. Locals from the

neighborhood, as well as tourists visiting the nearby Ocean Beach, patronize the business regularly. The owners describe the business as a “second home to many and a friend’s living room to others.”

Java Beach gives back to the community they serve. The owners and their staff helped start Neighborhood Watch within the community, sponsored surf contests, helped construct a bocce ball court, supported the creation of public art sculptures on Judah Street, and started a Merchant Association

Staff Analysis

Review Criteria

1. When was business founded?

Java Beach Café was founded in 1993.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes—Java Beach Café qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Java Beach Café has operated continuously in San Francisco for 31 years.
- b. Java Beach Café has contributed to the history and identity of the Outer Sunset neighborhood and San Francisco.
- c. Java Beach Café is committed to maintaining the physical features and traditions that define the organization.

3. Is the business associated with a culturally significant art / craft / cuisine / tradition?

Yes—Café’s are culturally significant for the craft of coffee. The Café opened during the “Third Wave of Coffee”. Café’s also have a long tradition for being communal gathering places such as being unofficial town halls, spaces for artists to showcase their craft, and as places to work.

4. Is the business or its building associated with significant events, persons, and / or architecture?

No.

5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

Not as of the date of this Executive Summary. The building was surveyed in the reconnaissance-level Oceanside Survey, but was never formally evaluated.

6. Is the business mentioned in a local historic context statement?

Not as of the date of this Executive Summary.

7. **Has the business been cited in published literature, newspapers, journals, etc.?**

Yes— Java Beach Café has been featured in *SFGate*, *Eater SF*, *7x7*, *Hyperflyer*, *The Bold Italic*, *Timeout*, *San Francisco Magazine*, *The San Francisco Chronicle*, and *Hoodline*.

Java Beach Café has also won numerous awards including the San Francisco Beautification Award for work done to the La Playa Pocket Park in 2009; Certificate of Honor from the Board of Supervisors in 2010, 2014, 2017 and 2019; a Gellert Family Business Award from University of San Francisco in 2014; and multiple Certificates of Recognition from politicians in 2017 including Assemblymember Tom Ammiano, Assemblymember Phillip Ting, Congresswoman Nancy Pelosi, and Congresswoman Jackie Speier.

Racial and Social Equity Analysis

On July 15th, 2020 the San Francisco Historic Preservation Commission adopted [Resolution No. 1127](#) centering Preservation Planning on racial and social equity. WHEREAS, in accordance with Administrative Code Section 2A.242, the Office of Small Business maintains a registry of Legacy Businesses in San Francisco (the "Registry") to recognize that longstanding, community-serving businesses can be valuable cultural assets of the City and to be a tool for providing educational and promotional assistance to Legacy Businesses to encourage their continued viability and success; and

WHEREAS, the subject business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years; and

WHEREAS, the subject business has contributed to the City's history and identity; and

WHEREAS, the subject business is committed to maintaining the traditions that define the business; and

WHEREAS, at a duly noticed public hearing held on July 17th, 2024, the Historic Preservation Commission reviewed documents, correspondence and heard oral testimony on the Legacy Business Registry nomination.

THEREFORE, BE IT RESOLVED that the Historic Preservation Commission hereby recommends that Java Beach Cafe qualifies for the Legacy Business Registry under Administrative Code Section 2A.242(b)(2) as it has operated for 30 or more years and has continued to contribute to the community.

BE IT FURTHER RESOLVED that the Historic Preservation Commission hereby recommends safeguarding of the below listed physical features and traditions for Java Beach Café.

BE IT FURTHER RESOLVED that the Historic Preservation Commission's findings and recommendations are made solely for the purpose of evaluating the subject business's eligibility for the Legacy Business Registry, and the Historic Preservation Commission makes no finding that the subject property or any of its features constitutes a historical resource pursuant to CEQA Guidelines Section 15064.5(a).

BE IT FURTHER RESOLVED that the Historic Preservation Commission hereby directs its Commission Secretary to transmit this Resolution and other pertinent materials in the case file 2024-005664LBR to the Office of Small Business on July 17, 2024.
