I. BACKGROUND

In 2016, San Francisco voters passed Proposition N, allowing certain non-citizen residents of San Francisco to register for and vote in local Board of Education elections. In order to be eligible to vote under Proposition N, a non-citizen resident has to be: 1) 18 or older on Election Day; 2) not imprisoned for a felony conviction; 3) not found incompetent to vote by a court; and 4) the legally-recognized parent, guardian, or caregiver of a minor child who also lives in San Francisco.

In May 2018, the Board of Supervisors passed related law requiring the Department of Elections (Department) to develop certain non-citizen specific voting materials, and in October 2021 made the Proposition N rules permanent for all local Board of Education elections, including recalls. Although in July 2022, a local Superior Court judge declared Proposition N unlawful, in August 2023, the California Court of Appeal reversed this ruling and upheld San Francisco's non-citizen voting program.

In the upcoming November 5, 2024 Election, local voters will fill four seats on San Francisco's Board of Education. In accordance with current local law, the Department will administer non-citizen voting for these four contests, providing a parallel set of registration and voting resources for non-citizen voters as well as outreach to non-citizens on these topics. Following the close of the voting period, the Department will then incorporate all valid non-citizen votes into its official citywide election results.

II. OUTREACH STRATEGIES

As part of the Department's commitment to providing accessible, equitable, and inclusive voter education to all San Francisco residents, its Outreach division staff will conduct a comprehensive non-citizen voter (NCV) outreach campaign. These multilingual, multiformat, non-partisan outreach efforts will disseminate information on essential NCV topics, including: registration rules and methods, voting options, resources, and tools, and contact information for organizations who serve local immigrants.

To ensure as many eligible non-citizen residents of San Franciscans as possible are aware of their right to register and vote in the 2024 Board of Education Election, the Department will utilize a wide variety of outreach strategies. These will include: digital distribution of NCV materials and information, NCV resource table hosting at local neighborhood events, virtual and in-person NCV voter education presentations, specialized NCV training workshops for community-based outreach partners serving immigrant communities, radio and newspaper advertisements about NCV, and interviews with local English and non-English language media outlets such as Telemundo 48, Univision, KTSF, KPIX, KCBS, KRON, and KIQI 1010 AM.

The Department will also facilitate collaborative NCV outreach with hundreds of local organizations and agencies who serve city residents. While some of these partnerships have been in place in prior Board of Education elections, others will be new for this election. In particular, the Department will work with the San Francisco Unified School District (SFUSD), the Office of Civic Engagement and Immigrant Affairs (OCEIA), the Latino Task Force (LTF), and the Immigrant Parent Voting Coalition (IPVC) as well as with local nonprofit organizations who will have successfully applied to serve as 2024 outreach grantees.

The Department also recognizes that its NCV outreach materials for the November 5, 2024 Board of Education Election will need to provide non-citizen parents, guardians, and caretakers with notification that NCV might affect their immigration status or naturalization progress. In particular, the Department's outreach materials will include (as required by law) IMPORTANT NOTICE FOR NON-UNITED STATES CITIZENS, which alerts that the Department may be required to disclose local voter data to Immigrations and Custom Enforcement and other agencies, organizations, and individuals.

Along with this Notice, the Department will disseminate information on recent changes to the federal government’s N-400 Naturalization Application¹, which includes a question² about voting history in local, state, and federal elections. Per this change, many San Francisco NCV voters may now be able to respond “No” to the question “Have you EVER registered to vote or voted in any Federal, state, or local election in the United States?” given that the form now includes the instruction “If you lawfully voted only in a local election where noncitizens are eligible to vote, you may answer, ‘No.’ “ Nevertheless, the Department will continue to direct potential NCV registrants concerned about this issue to seek guidance from immigration attorneys before sharing personal information with the Department or registering to vote.

Note: The period for all outreach methods described below will run June to November 2024 unless otherwise noted.

A. PRINTED NCV SPECIFIC MATERIALS

By law, non-citizen voters must register for each Board of Education election and cannot do so using the California Secretary of State’s online application, by making a qualified transaction (e.g., obtaining a driver license or registering a vehicle) at the California Department of Motor Vehicles, or by completing the paper state voter application. This is because each of those methods requires an attestation of United States citizenship. The Department’s Non-Citizen Voter Registration Form, available in print and via download, currently serves as the only means by which non-citizens can register to vote in San Francisco.

The NCV registration form indicates that it does not entitle registrants to vote in any other local, federal, or state elections.

The Department will also produce its full array of multilingual printed NCV-specific registration, voting, and outreach materials for the November 2024 Board of Education Election. These materials will include NCV-specific voter registration and cancellation forms, the NCV Board of Education Election Reminder Letter³, the NCV Voter Information Booklet⁴, the single-card Board of Education ballot, and the Guide to Registration and Voting Process for Non-Citizens,⁵ as well as various flyers⁶ and posters.

1. Initial NCV Printed Materials Distribution

The NCV single-election voter registration form for the November 5, 2024 Board of Education Election is now available online at sfelections.org/NCV as well as in paper format. This form has been fully translated (as required by law) into Chinese, Spanish, Filipino, Vietnamese, and Arabic with the legally-mandated Important Notice for Non-United States Citizens being translated into all 49 required languages.

The Department’s Registration and Voting Guide for Non-Citizen Parents and Caregivers is a comprehensive resource, with key information about non-citizen voting distilled into twelve, easy-to-read pages. The cover shows the IMPORTANT NOTICE FOR NON-UNITED STATES CITIZENS, as required by law, and for the convenience of potential NCV voters.

Inside this quadrilingual guide, readers will find Department contact information, November 2024 election dates, an eligibility checklist, and detailed instructions on the voter registration process. Its readers will also learn how to find information about

Board of Education candidates and mail and in-person voting options. At the end, readers will see a list of voting rights and contact information for a number of local organizations serving immigrant communities.

The Department has also created a new NCV flyer for the 2024 Board of Education Election. This new bilingual flyer, which is available in English, Chinese, Filipino, and Spanish, includes the required notice and information on NCV eligibility and voting processes.

The NCV guide, along with NCV registration and cancellation forms, and the NCV informational flyer, are all available on the Department's NCV webpage, sfelections.org/NCV as well as at the Department's Room 48 office in City Hall. In addition, outreach staff will distribute these NCV printed materials directly to interested residents at many in-person community events, voter education presentations, and voter registration drives. The Department will also deliver these NCV materials to hundreds of outreach partners, including many local non-profits and schools, who will distribute them to non-citizen parents in turn.

2. NCV Reminder Letter

Approximately six months before each Board of Education election, the Department sends a letter to all the non-citizen voters who participated in the last Board of Education election, reminding them that they may register again for the next such election.

3. Regular Press Releases

The Department issues regular press releases to a group of approximately three hundred interested parties, composed mainly of local journalists, the media, and members of community-based organizations. Many of the press releases for the upcoming November 5, 2024 Election will include announcements pertaining to non-citizen registration and voting. Anyone interested in receiving press releases from the Department of Elections may sign up at sfelections.org/trustedinfo.

4. Certificates of NCV Eligibility and Registration

Upon request, and pursuant to San Francisco Municipal Elections Code Section 1004(a), the Department can provide a letter⁷ to any non-citizen voter confirming they have lawfully registered for a Board of Education election under San Francisco Charter §13.111(a)(1)(B). This letter also cites the relevant part of the law exactly. Similarly, the Department will provide a letter upon request: a) listing the criteria set forth in Charter §13.111(a)(1) for non-United State citizens to register and vote in local Board of Education elections, and b) verifying that a given person has in fact voted in a specific Board of Education election.

5. Voter Information Booklet

For the November 5, 2024 Election, the Department will produce a separate Voter Information Booklet (VIB) with information for local non-citizen voters. The VIB will be printed in English, Chinese, Spanish, and Filipino. The VIB will be mailed to all non-citizen registrants and posted on sfelections.org by October 7 in accordance with CAEC §13307(b) and MEC §500. The VIB will include a sample ballot, information about candidates, voting options, and election processes. Its back cover will feature the location of the recipient's assigned polling place.

B. WEBSITE

The Department recently updated its NCV webpage⁸ at sfelections.org/NCV. This easier-to-read webpage includes quick links to the NCV registration and cancellation forms and the non-citizen voter information portal as well as information on NCV eligibility requirements, registration, and voting options. It also includes links to immigration-related resources and to

organizations in the Immigrant Parent Voting Collaborative, answers to frequently asked questions, and the legally mandated IMPORTANT NOTICE FOR NON-UNITED STATES CITIZENS.

In addition, the new NCV webpage incorporates three new drop-down panels, namely, 1) Effect on Naturalization Application, 2) Outreach Materials, and 3) History of NCV in San Francisco. The first panel provides a link to the recently revised N-400 Application for Naturalization, along with a brief summary of the revision most relevant to NCV voters. Copy on this panel also encourages non-citizens seeking advice about their particular naturalization cases to contact an immigration professional. The second panel provides links to NCV-specific printed materials along with an NCV presentation. The last panel provides background information on the history of NCV in San Francisco. It also explains that, by request, the Department can provide certificates of NCV eligibility and registration. All new panels have been translated⁹ into Spanish, Chinese, and Filipino.

C. IN-PERSON OUTREACH

To complement NCV print and online outreach, Department outreach staff have begun conducting a variety of NCV voter education outreach presentations at community events throughout the city. In order to better accommodate the different needs of different schools, government agencies, and community-based organizations, the Department offers an array of in-person resources and outreach opportunities including voter education presentations, resource tables, registration pop-up events, and training workshops.

1. NCV Presentations

NCV education presentations are already a core element of the Department's in-person voter outreach for the November 2024 election cycle, with Department outreach staff conducting NCV education presentations for community-based organizations, schools and government agencies that serve immigrant populations. All such presentations include key information on the history of NCV in San Francisco, NCV registration eligibility requirements, NCV registration and voting processes, accessible voting resources, and contact information for community-based organizations serving non-citizen residents of San Francisco.

2. NCV Resource Tables

The outreach team has already begun hosting resource tables at many community events in neighborhoods across the city. At these resource tables, multilingual Department staff can answer questions about NCV registration requirements and voting processes and assist with NCV registrations. They often also provide NCV information to interested parties via the distribution of printed materials such as the NCV flyer and the Registration and Voting Guide for Non-Citizen Parents and Caregivers.

3. NCV Workshops

The Department will continue to work closely with community-based partnership organizations and provide their community ambassadors the training, tools, and information they need to educate non-citizen residents on the history of and eligibility requirements for non-citizen voting and to assist non-citizen residents interested in registering to vote in the November 2024 Board of Education Election. In particular, Department staff will conduct training workshops with OCEIA and other community-based partners to ensure their staff are fully prepared to engage in NCV outreach to immigrant communities.

4. NCV Merchant Walks

The Department's outreach team will conduct "merchant walks" in neighborhoods with larger concentrations of immigrants and/or residents who speak languages other than English. Outreach merchant walks in the past have proven to be highly effective and cost-efficient ways to conduct voter outreach in San Francisco. As part of these walks, staff will distribute printed NCV materials to local business owners and ask them to display the materials in their storefronts.

D. SCHOOL/PRE-K PARTNERSHIPS

1. Local Schools

The Department is partnering closely with SFUSD staff to disseminate NCV related information. Through this partnership, Department staff have shared NCV materials via some of SFUSD's established communication channels, including the OASIS newsletter (distribution to school staff) and the weekly Family Announcement Bulletin (distribution to families). The Department is also providing NCV printed materials, including NCV flyers and NCV Registration Forms, to the SFUSD main office on Franklin Street for display.

The Department is also working with local schools beyond the SFUSD, including the Chinese American International School, the French American International School, La Scuola, and the Lycée Français de San Francisco. As with the above public school partnerships, through these private school partnerships, the Department will provide NCV materials and resources to more families.

2. Local Preschools

To expand its NCV outreach to the local non-citizen parents, guardians, and caretakers of young children who are not yet enrolled in school, the Department has contacted a number of public agencies and community-based organizations who serve families with young children. These include the San Francisco Department of Early Childhood, the Children's Council of San Francisco, Safe & Sound, Recess Collective, and the San Francisco Child Care Planning & Advisory Council. Through these partnerships, the Department will provide outreach on NCV, explaining as necessary that Proposition N and its successor legislation allows most non-citizen parents of children who *reside* in the SFUSD to vote; they do not need to *attend* SFUSD.

E. PARTNERSHIPS WITH CITY AGENCIES AND COMMUNITY-BASED ORGANIZATIONS

As a major part of its NCV outreach for the November 5, 2024 Board of Education Election, the Department's outreach team will continue to utilize a number of longstanding partnerships with trusted local government agencies and community-based organizations serving local immigrant populations. These include the City's Office of Civic Engagement and Immigrant Affairs, the Latino Task Force, the Department of Children, Youth and their Families, and the Immigrant Parent Voting Collaborative.

These partners in turn work with many other organizations, including: the African Advocacy Network, the Arab Resource and Organizing Center, the Central American Resource Center, Chinese for Affirmative Action, Coleman Advocates for Children and Youth, La Raza Community Resource Center, the Mission Economic Development Agency, and Mission Graduates. As trusted sources of information for local immigrant communities, these outreach partners will serve a vital role in helping the Department inform eligible non-citizen parents, guardians, and caretakers about their right to vote in the upcoming election.

1. Language Accessibility Advisory Committee

First, in the provision of NCV outreach, the Department will continue to partner with all members of its Language Accessibility Advisory Committee (LAAC). This group, formed in 2017, works to make voting in languages other than English easier.

Department representatives at LAAC meetings often seek the community's input on NCV outreach to non-English speaking communities.

2. Office of Civic Engagement and Immigrant Affairs

Second, the Department will continue to work closely with San Francisco's Office of Civic Engagement and Immigrant Affairs (OCEIA), with whom it has had a valuable and successful relationship for numerous elections. San Francisco's OCEIA is a policy, compliance, direct services and grant-making office whose mission, in part, is to foster immigrant assistance programs that lead to full civic, economic and linguistic integration. As in past elections, the Department will conduct training workshops with the diverse, multilingual members of OCEIA's Community Ambassador Street Team to help prepare them to educate non-citizen residents about the upcoming Board of Education Election. OCEIA ambassadors are critical, on the ground allies in San Francisco's efforts to reach non-citizen residents who may not receive key election information via traditional methods.

3. Latino Task Force

Third, the Department will continue to expand its partnership with San Francisco's Latino Task Force (LTF), which serves as a bridge connecting local low income and non-English speaking communities with life-affirming services and opportunities for enhanced cultural, economic, social, and civic engagement. Through this partnership, the Department's outreach staff now participate in LTF's weekly Monday meeting series, where they can share upcoming events of interest to members of Spanish-speaking and other non-English speaking communities and provide program partners with information on NCV and outreach opportunities. Three times per month, outreach staff also host NCV resource tables and answer questions at LTF's community hubs: Mission Hub on Alabama Street, the Executive Park Hub in the Bayview and the Excelsior Hub at Casa de Apoyo.

4. Immigrant Parent Voting Collaboration

Fourth, for this NCV election cycle, the Department is expanding its indirect outreach partnership with the Immigrant Parent Voting Collaborative (IPVC), a network of community-based organizations: African Advocacy Network, Arab Resource and Organizing Center, Central American Resource Center, Chinese for Affirmative Action, Coleman Advocates for Children and Youth, La Raza Community Resource Center, Mission Economic Development Agency, and Mission Graduates. For the November 2024 Board of Education Election, outreach staff will leverage their longstanding partnership with IPVC to provide NCV outreach to non-citizen residents who may not seek out election-related information through traditional methods

5. Department of Children, Youth, and Their Families

Fifth, the Department is also expanding its collaboration with staff at the Department of Children, Youth, and Their Families (DCYF) to provide information about NCV to community-based organizations who work with DCYF. The DCYF creates and facilitates innovative citywide policies and projects in support of children, youth, and families. As part of this expanded joint effort, the DCYF will publish information about NCV in their monthly newsletter, which they send to approximately 300 grantees who work exclusively with children and families in San Francisco. The DCYF will also highlight NCV via its social media accounts and *sfkids.org*, which together reach approximately 4,000 followers and distribute the Department's NCV materials.

6. Other Organizations

Finally, the Department is working with several other community-based organizations who serve local immigrant populations to provide staff at these organizations the tools they need to assist non-citizen residents interested in registering to vote for the upcoming election. To help prepare them, the Department will offer presentations on NCV eligibility requirements, voting processes and accessible voter resources and hold voter registration pop-ups to bolster the efforts of non-profit organizations.

F. MEDIA STRATEGIES

This fall, in partnership with local media personalities, Department staff will give interviews - in Chinese, English, Filipino, and Spanish - through numerous newspapers and media outlets, including Univision, Telemundo 48, KTSF, KIQI 1010 AM, World Journal, El Reportero, and the Sing Tao Daily. In these interviews, which the Department will continue to schedule over the summer, staff will inform San Franciscans about non-citizen voting and let them know where to find more information.

G. POLL WORKER TRAINING

The Department will develop a comprehensive training curriculum and update its Poll Worker Manual for the November 2024 election. This curriculum reflects the Department's commitment to always preparing each and every poll worker to effectively and efficiently serve all precinct, vote-by-mail, and provisional citizen and non-citizen voters.

The poll worker training curriculum therefore explains in detail how to provide inclusive, equitable, and accessible voter support services to non-citizen voters and clear and simple instructions regarding the distribution of NCV ballots. The NCV portion also educates poll workers on non-citizen voting eligibility requirements and rights, and covers procedures for processing both non-provisional and provisional NCV voters in detail using job cards and the use of discrete voter questioning techniques.

III. PLAN ASSESSMENT

Following the November 5, 2024 Election, the Department will conduct an assessment of this NCV Outreach Plan. This assessment will incorporate both quantitative data, such as the number of community events attended, the number of materials distributed, and the number of new partnerships established, and qualitative data, including surveys feedback from voters and outreach event attendees, along with feedback from outreach partner organizations. The Department will aggregate data by each community reached and will seek to identify useful correlations between relevant datasets and election outcomes. This assessment will be used to refine and improve future NCV outreach and education strategies going forward.

IV. APPENDIX

A. Terminology Notes

The official title of the elected body which manages the San Francisco Unified School District (SFUSD) is the “San Francisco Board of Education”, but this body is sometimes also referred to simply as the “School Board”.

“NCV” means non-citizen voting generally while “EDU” is an acronym sometimes used by the Department of Elections to refer specifically to non-citizen voting in San Francisco Board of Education elections and ballots listing only School Board contests.

You may wish to consult with an immigration attorney, an organization that protects immigrant rights, or other knowledgeable source before providing any personal information to the Department of Elections and before registering to vote in San Francisco Board of Education Elections. You can find a list of nonprofit organizations that specialize in protecting the rights of immigrants on sfelections.org.

INSTRUCTIONS

1. In **Section A**, review eligibility requirements and complete fields.
2. In **Section B**, affirm under penalty of perjury that you are eligible to vote in the School Board election and that all information is true and correct. Sign and date.
3. **Return this form to the Department of Elections.** To return by mail, fold the form to connect the red triangles on the left, and then connect the blue dots. Use tape to seal. To return in person, visit the Department's office in City Hall, Room 48.

Once the form is processed, the Department will mail you a Notification Letter to confirm your registration. If you do not receive the letter within a week, call (415) 554-4375.

To vote as a non-citizen, you must fill out the [NCV registration form](#). You must mail the form or drop it at our office at City Hall.

What to do



Current local law allows certain non-citizens to vote in San Francisco's Board of Education (School Board) elections. **This law does not allow individuals to vote in any other local, state, or federal election.**

Check if you're eligible

To register as a non-citizen voter for the next Board of Education (School Board) election, you must be **all of the following**:

1. A San Francisco resident who intends to remain so until the next Board of Education election;
2. The parent, legal guardian, or caregiver of a child living in the San Francisco Unified School District (i.e. living in San Francisco);
3. At least 18 years of age on Election Day (the next such date is November 5, 2024); and
4. Not disqualified from voting under state law for imprisonment or mental incompetence.

Register

Local law requires all non-citizen voters to register for Board of Education elections using a postage-paid [NCV registration form](#). This form is also available at the Department's office. Completed non-citizen registration forms must be returned by mail or in person. A new NCV registration form must be completed for each Board of Education election by any non-citizen voter.

Non-citizen voters cannot use the state voter registration form or register at state offices (e.g., Department of Motor Vehicles).
