In the beginning of April 2024, the Community Engagement Division (CED) of the San Francisco Police Department created a new division within the department known as the Neighborhood Safety Team (NST). This new division has taken over the role and duties formerly assigned to the non-profit, SF SAFE.

With this new division came the creation of the new NST logo necessary for our NST team uniform shirts. Please note that our NST team members will be wearing these new uniforms when responding out to meet with members of the community. These uniforms will be used to help the members of our community identify our NST community safety team members.

The new NST team uniforms were made by Graphic Sportswear located at 173 Utah Avenue South San Francisco, CA. 94080. The cost of the new NST uniform shirts and patches is \$494.44. The San Francisco Police Foundation has granted funds to purchase these uniforms. We are requesting that the San Francisco Police Commission approve these granted funds.
