1. Call to Order/Introduction

2. LBEAC Recognition

- a. Ivy Fine, Director of Infrastructure, thanked Greg Lyman for his years of public service and announced that Kyndra Cox will represent PUC at future LBEAC meetings.
- 3. Government operations overview: procurement spotlight Molly Peterson, Contracts Reform Manager
 - a. Molly Peterson reported the following:
 - i. The Government Operations team (Gov Ops) was created to improve City procurement efficiency.
 - ii. Gov Ops has helped improve the LBE program and increase access to City contracting opportunities.
 - b. Following Supervisor Mandelman's 2022 inquiry about low-value contract procurement issues, the City Administrator's Office released a report with the following recommendations:
 - i. Improve the informal procurement process.
 - ii. Simplify terms and conditions.
 - iii. Amend legislation to update and reconcile contracting requirements.
 - iv. Explore standardization in future procurement legislation.
 - v. Increase coordination across departments that interact with suppliers.
- 4. Director's Report Stephanie Tang, Director of CMD
 - a. Stephanie Tang presented the following information:
 - i. CMD has hired 2 new Compliance Managers.
 - ii. LBE stakeholders are not aware of their right to request early release of retention per the City's Administrative Code.
 - 1. CMD is contacting LBEs to remind them of this perk and to provide a template letter to request their retention when their scope of work is finished.

- iii. CMD is resuming Construction Site Visits
- iv. New LBE credit restrictions allow new LBEs to form while still offering protection against potential misuse of the program.
- v. Public-facing PeopleSoft applications are being reworked to be more user-friendly.
- vi. The US Treasury Department is requiring all businesses, including LBEs, to file a beneficial ownership report before January 1, 2025.
