President Collins asked for any agenda changes and no changes were suggested.

President Collins introduced Lydia So as the new ex officio joining the Full Commission meetings.

President Collins announced the public meeting instructions.

Commission Secretary Dhaliwal announced public comment instructions.

President Collins began the meeting by reading the Arts Commission's land acknowledgment statement.

3. General Public Comment (12:18)

Written Public Comment:

Amy Foote, Unionized member of SF Symphony Chorus though American Guild of Musical Artists:

"The SF Symphony is not prioritizing funds received to the Symphony chorus. This leaves its current regular unionized choral musicians struggling to live and work in San Francisco. Singing with the SF



Symphony has been one of the most lucrative union gigs still available in SF and is essential to protect.

This arts commission can make sure that when it grants money to an organization, that organization uses the money toward their working artists. When you donate to the SF Symphony, I implore you to make sure they put the money into their musicians, their choral members and players living and working in SF, so we (and I) can continue living here, making this a more artistic, creative, and welcoming place to live and maybe even someday thrive."

Elliott James Encarnación:

"I have been a professional chorister at the San Francisco Symphony since 2013. I am a governor in the union which represents the chorus' bargaining unit at the Symphony, AGMA (American Guild of Musical Artists). In recognition of this body's annual disbursement of funds to the Symphony, I am calling for scrutiny and careful oversight over how those funds are spent. It is my belief, as we engage in contract negotiations, that the Symphony has misrepresented its financial situation to the public and to its donors. The Symphony should and must leverage its artistic assets like the Chorus to solve its fundraising challenges, not destroy its working artists in attempting to balance its budget. I ask this Commission to make ensure the Symphony, as a grantee, is fulfilling its mission and investing in the artists who make its work possible."

Public Comment

Ximena Zhao a second-generation Native American artist spoke about non-resident artists being awarded grants that are supposed to be for resident artists. Zhao mentioned the difficulties of expense living in San Francisco and not being awarded any grants. Zhao shared their complaint about a 2023 artist grantee that they believed didn't meet the requirements. Zhao wants a regranting.

There was no additional public comment.



4. Committee Reports and Committee Matters (22:43)

1. Civic Design Committee Report (22:50)

Chair Schnair shared the approval of two conceptual project review San Francisco Fire Department Division of Training Facility. She described the San Francisco Fire Department Division of Training Facility project. She mentioned the purpose of the facility is to provide an upgraded training campus for firefighters and emergency medical technicians to meet the evolving needs of emergency responders in a 21st-century urban environment. She detailed the new space will provide for live-fire training, classroom training, equipment training and emergency medical services training. She stated the project will consolidate existing San Francisco Frie Department training facilities in one new location, replacing current training facilities in the Mission District and on Treasure Island, which the San Fransico Fire Department must soon vacate.

Chair Schnair continued with an explanation of the second conceptual review Moccasin Engineering & Records Building. She shared the building will provide offices for the Engineering and Records departments and shall be contemporary in design while complementary to existing building at the Moccasin Yard. She shared the landscape and building are exposed to the West side of the project site, taking advantage of the views of the Old Moccasin Powerhouse and the adjacent Moccasin Reservoir.

2. Visual Arts Committee Report (29:54)

Chair Ferras shared *The Only Blue is the Sky* by Craig Calderwood was presented as installed. She said the work was completed with



the help of Precita Eyes Muralists who has been a leading San Francisco mural arts organization based in the Mission since 1977 and included the mural spans three floors of the new Harvey Milk Terminal 1. Chair Ferras stated that Suzanne Husky's *Close Encounter with the California Sublime* was also presented as installed, in Harvey Milk Terminal One. She mentioned Jet Martinez's *Fog Lilies* was presented as installed for the Westside Pump Station. Chair Ferras concluded her report by sharing three major conservations projects of the Civic Art Collection were presented – *Mechanics Monument*, *Dewey Monument*, and *Lotta's Fountain*.

There is no public comment.

5. Agencywide Strategic and Business Plan Contract (40:55)

Deputy Director of Finance and Administration Sarah Hollenbeck presented the action to authorize the Director of Cultural Affairs to enter into an agreement with AMS Planning & Research Corp as soon as August.

He also stated that the Chinatown Artist Registry Request for Qualifications will launch July 11, the Arts Commission and the Chinese Cultural Center will hold a joint press conference at Portsmouth Square.
