Summary of Complaints Received in July 2024


The Department of Police Accountability received a total of 63 cases in July 2024, 56 SFPD complaints and 7 SFSO complaints. Compared with a total of 65 cases, 63 SFPD complaints and 2 SFSO complaint, in the same period last year, the July 2024 case total is 7% lower than the five-year average and the 3% lower than the previous year.

From January through July, the DPA received a total of **450** new cases, **425** SFPD complaints and **25** SFSO complaints. Compared with the **464** cases filed during the same period in 2023, **441** SFPD complaints and **23** SFSO complaint. The July year to date case total represents a **3%** decrease in new complaints over last year.



Currently, DPA has a total of 220 pending cases, 196 SFPD and 24 SFSO.

In July, DPA <u>received</u> a total of **1** referral(s) from SF Sheriff's Office and <u>referred</u> a total of **1** case(s) to SFSO.


