#### **BUSINESS DESCRIPTION**

Yadav Diamonds and Jewelry is a jewelry store opened by Yair Yachdav in June 15, 1983, and was originally located at 760 Market Street. Yadav Diamonds and Jewelry sells wholesale diamonds, engagement rings, and other jewelry pieces. Prior to immigrating to the United States in 1983, Yair had about a decade of experience learning the diamond business as a diamond cutter. He moved to San Francisco and started his own business. At his 760 Market Street location, he sold diamonds and jewelry stores across the country.

In 1995, Yadav Diamonds and Jewelry outgrew its location and moved to 999 Brannan Street. As they were settling into their new location, the building was purchased, and Yadav Diamonds and Jewelry moved to their current location at 888 Brannan Street. As they moved to their new location in 2000, they have expanded their services to the internet and sell their goods internationally. As the business became international, Yadav Diamonds and Jewelry has opened offices in Los Angeles, Hong Kong and Mumbai.

Currently, Yair is happy to transition the business to his daughter, Maytal Yachdav, for her to be the future of the business. Besides providing explementary consulting and customer service, Yadav Diamonds purchases and sells diamonds that are ethically created. Yadav Diamonds and Jewelry provides the option for consumers to purchase conflict free diamonds. Yadav Diamonds and Jewelry believes that they can benefit their community socially, ethically, and environmentally by sourcing their diamonds and materials that are made from sustainable methods to reduce environmental footprints. They sell conflict-free natural diamonds and labgrown diamonds and jewels. They have gemologist to consult with clients on what is a good fit for each client.

As a family-owned jewelry businesses, Yadav Diamonds and Jewelry aims to be more involved with community events and organized. Yadav Diamonds and Jewelry sells jewelry for all income brackets with multiple selections and choices. Yair also regularly participates in community meetings and industry meetings. Yadav also hires people from a diverse background. Eighty percent of Yadav Diamonds and Jewelry are female and Ninety percent are immigrants.

#### **CRITERION 2**

Yes, Yadav Diamonds and Jewelry has contributed to the history and identity of the South of Market neighborhood and San Francisco.

The Historic Preservation Commission recommended the applicant as qualifying, noting the following ways the applicant contributed to the neighborhood's history and/or the identity of a particular neighborhood or community:

- The business is associated with the jewelry art.
- The current building Yadav Diamonds and Jewelry, 888 Brannan Street, is in the Showplace Square Historic Resource Survey area as an historic resource. The building is listed as an individual resource in the National Register and California Register, for architecture and has a Planning Department Historic Resource status codes of "A" (Historic Resource Present) because of its status as an individual resource listed in the registers. Further, the building is located within the eligible SOMA Historic District. It is also within the boundaries of an ongoing Neighborhood Commercial Corridors Historic Resources Survey.
- The business has attempted to join community fairs but were closed due to COVID-19 pandemic. The business actively contributes to environmental practices that benefit the community consumers. They source their diamonds and materials from ethical methods to reduce environmental and social impacts, like purchasing conflict-free natural diamonds and using lab-grown jewels.
- Yadav Diamonds and Jewelry has been mentioned in publications like Hoodline and US Weekly. They have been mentioned on online sites like City Seeker, Ice Gold, The Knot, Rare Carat, Trust Pilot, Wedding Day, Wedding Wire, and WillYou.net.

## YADAV DIAMONDS AND JEWELRY Section 4: Written Historical Narrative

#### **CRITERION 1**

a. Provide a short history of the business from the date the business opened in San Francisco to the present day, including the ownership history. For businesses with multiple locations, include the history of the original location in San Francisco (including whether it was the business's founding and or headquartered location) and the opening dates and locations of all other locations.

Yadav Diamonds and Jewelry ("Yadav Jewelry" or "YADAV"), currently located at 888 Brannan Street in suite 1100, was established in 1983 by Yair Yachdav.

Yair immigrated to the United States in 1983. With about a decade of experience overseas learning the diamond business and working as a diamond cutter, he started his own company in San Francisco from a humble and straightforward beginning as a diamond supplier.

From 1983 to 1995, YADAV was in San Francisco Phelan Building at 760 Market Street in the Financial District, which was once home to the George Haas and Sons Candy Store, marketed as the most beautiful candy shop in the country. The business was originally located in the. From the Phelan Building location, Yair sold wholesale diamonds to jewelry stores across the country.

In 1995, YADAV moved to 999 Brannan Street, a four-story property in the South of Market District. The building, designed by Tanner & VanDine Architects, has a glass facade that wraps around its curving triangular structure along with rooftop parking and a penthouse conference room. In 1998, Dolby Family Ventures purchased the building, so Yadav Diamonds and Jewelry had to move again. In 2000, YADAV moved to its present location at 888 Brannan Street to the San Francisco Gift & Jewelry Center and began selling diamonds and engagement rings directly to the public.

The San Francisco Gift & Jewelry Center is the city's premier shopping destination, featuring 100 showrooms. Step inside and you will find a diverse collection of gifts, jewelry, and accessory showrooms representing over 270 product categories, including imported products from over 25 countries. Choose from a seemingly endless selection of wedding and engagement rings, gems, precious metals, fine watches, fashion jewelry, and designer goods. You will walk away with jewelry of exceptional style, color, and fit – at a fraction of the price you'd normally pay anywhere else.

In 2000, Yadav Jewelry also expanded its services to selling diamonds online to people all around the world shopping for engagement rings.

Having increasing experience in selling diamonds, Yair built an extensive network, expanding his business in 2010 from San Francisco to Los Angeles, and internationally from Hong Kong to

Mumbai, India. With vision and grit, Yair has grown from being a diamond dealer to one of the most trusted diamond engagement ring providers in the United States.

## b. Describe any circumstances that required the business to cease operations in San Francisco for more than six months?

YADAV has not ceased operations since it was established in 1983 aside from a short period of time in 2020 at the beginning of the coronavirus pandemic. Since Yadav Diamonds and Jewelry has an online presence, their business was not affected as much as it could have been. YADAV takes pride in offering the best services and accommodating their customers even during hard times, ensuring safe and quality service to their customers during the pandemic. YADAV also offers assistance from a certified gemologist, whose advice provides a sense of confidence for their customers, especially first-time buyers. Customers can be reassured when shopping at YADAV.

## c. Is the business a family-owned business? If so, give the generational history of the business.

Yadav Diamonds and Jewelry has been a family-run business since the beginning. In 1983, Yair Yachdav immigrated to the United States and started Yadav Jewelry. He has been the sole owner ever since. His knowledge and expertise in diamonds surpasses any other diamond merchant in the United States, having over 40 years of experience.

In 2018, Yair's youngest daughter, Maytal Yachdav, joined the family business. Maytal is the future of YADAV. Her smiling face and strong personality often lend customers to a memorable shopping experience. Her strong bond with her family and its legacy made her decide to join YADAV at an incredibly young age. A happy person at heart, she loves spending time with her family. Satisfied smiling customers keep her motivated to take the business to the next level.

d. Describe the ownership history when the business ownership is not the original owner or a family-owned business.

The ownership history of Yadav Diamonds and Jewelry is as follows:

e. The historic resource status of the building at 888 Brannan Street is classified by the Planning Department as Category A, Historic Resource Present, regarding the California Environmental Quality Act. The building was constructed in 1956 and is historically known as the California Flower Market. This property has been identified for its association with modern architecture and landscape design (1935-1970). The building was listed on the National Registry in 1982, and it appears eligible for listing on the California Registry as a contributor to the Central SoMa Historic Resource Survey.

Located in the building is the San Francisco Gift & Jewelry Center, the biggest gift and jewelry center in the city. Also located in the building is Airbnb's headquarters.

#### **CRITERION 2**

a. Describe the business's contribution to the history and/or identity of the neighborhood, community or San Francisco.

Yadav Diamonds and Jewelry is a contributing business to the San Francisco Gift & Jewelry Center in the SoMa neighborhood. The Gift & Jewelry Center is a diverse collection of gift, jewelry, and accessory showrooms representing over 270 product categories, including imported products from over 25 countries. Shoppers in the center can choose from a wide selection of wedding and engagement rings, gems, precious metals, fine watches, fashion jewelry, and designer goods such as scarves, sunglasses, and handbags. The building at 888 Brannon Street was originally constructed in 1912 by the National Carbon Company. It later served as a paper warehouse for Blake, Moffitt, and Towner. In 1983, it was converted into a wholesale mart, housing both gift and jewelry showrooms. More recently, the San Francisco Gift & Jewelry Center went through a major exterior and interior renovation, adding more space and light and a grand glass atrium.

YADAV has contributed to environmental practices that benefit the community socially and economically. The company sources diamonds and materials through ethical methods to reduce environmental impacts, such as conflict-free natural diamonds and lab-grown diamonds and jewels. YADAV is also dedicated to creating happy client experiences. It strives to be a positive, driving force in the community, and to help those who are less fortunate whenever they can.

b. Is the business (or has been) associated with significant events in the neighborhood, the city, or the business industry?

Yadav Diamonds and Jewelry has not participated in any significant events or fairs. It planned to join a couple of industry and community fairs in 2020; unfortunately, all the events were cancelled due to the coronavirus pandemic.

#### d. Is the business associated with a significant or historical person?

Yadav Diamonds and Jewelry considers all their customers to be significant. The business has had a few famous individuals pay a visit to their showroom, but YADAV would like to respect the privacy of their customers and not provide specific details.

#### e. How does the business demonstrate its commitment to the community?

Yadav Diamonds and Jewelry is committed to working with area businesses, community groups, and its neighbors to improve San Francisco by implementing environmental projects that benefit the city socially and economically. The business strives to be a positive, driving force in the community and is dedicated to creating happy client experiences. The owner Yair Yachdav has been participating regularly in community meetings hosted by the neighborhood and participating in as many industry meetings as possible.

YADAV helps those less fortunate whenever they can. The business provides all levels of job opportunities to diverse people. Eighty percent of YADAV's employees are female, and 90 percent are immigrants. The store employees two students as part-time workers, as well as a couple of new graduates.

#### f. Provide a description of the community the business serves.

Yadav Diamonds and Jewelry sells excellent quality engagement rings with diamonds certified by the Gemological Institute of America (GIA) and International Gemological Institute (IGI). Yadav Jewelry's customers live both locally and nationally and are generally couples with lower budgets for rings. Yadav Jewelry is one of the few suppliers in the United States that provides consumers with the option to purchase lab-created diamonds. Lab diamonds are guaranteed

conflict-free and are between 30-40 percent less expensive on average than traditional diamonds on average.

## g. Is the business associated with a culturally significant building/structure/site/object/interior?

Yadav Diamonds and Jewelry is located in the San Francisco Gift & Jewelry Center at 888 Brannan Street, which is a culturally significant building. Originally built by the National Carbon Company in 1912, this historic structure at the corner of 8th and Brannan streets in SoMa housed a manufacturing facility for Eveready Batteries in 1916. Today it has been completely renovated and leased to Airbnb for their headquarters as well as the San Francisco Gift & Jewelry Center. Added to the National Register of Historic Places in 1982, the five-floor concrete building once had train tracks running right through the area that is now the entrance lobby and central atrium. The atrium today pays homage to the building's history with train tracks carved right into the polished concrete floor.

## h. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

The National Carbon Company Building is a major architectural example of the reinforced concrete industrial structures built in San Francisco in the early 20th century.

Designed by prominent local architect/engineer Maurice Couchot and built in 1917, it clearly describes its period of construction. With its attention to practical considerations as well as aesthetics, it exhibits the ambiguity typical of the City Beautiful Movement popular in San Francisco at that time.

Foremost, it is an industrial structure built with the latest technology and materials. It featured reinforced concrete construction, a sophisticated ventilation system, a sprinkler system, and an intercommunications system of telephones, pneumatic tubes and spiral chutes. But on top of its industrial design Couchot applied oversize classical ornamentation such as High Style door surrounds, spandrel panels and medallions. These features, as well as its scale, distinguish the building and make it highly visible in its South of Market Street industrial neighborhood.

Nearby industrial structures dating from the same era (1905 to 1930) are of brick or reinforced concrete construction. Although similar in function and construction, there are few that match the National Carbon Co. Building in scale or prominence. The architect Maurice Couchot was well-qualified to design industrial structures.

As the business became international, Yadav Diamonds and Jewelry has opened offices in Los Angeles, Hong Kong and Mumbai. Currently, Yair is happy to transition the business to his daughter, Maytal Yachdav, for her to be the future of the business.
