Chief’s Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime down 11 percent; homicide down 39 percent; rape down 9 percent; robbery down 17 percent; assault down 4 percent; human trafficking down 40 percent. Property Crimes down 34 percent; burglary down 19 percent; motor vehicle theft down 18 percent; arson down 11 percent; larceny theft down 40 percent. Gun violence is down 33 percent compared to 2023; Eight non-fatal shooting incidents this week; total 71 fire-arm related incidents resulting in 80. victims YTD. No homicides for the week; there are a total of 17 homicides YTD with 12 resulting from a firearm; 89% overall clearance.

Significant Incident: Homicide, 7/9/24 00:17, Officers responded to the area of Mission between 16th and 17th street, located a victim who was shot and declared deceased at the scene, multiple spent bullet casings of a variety of calibers were located indicating that there were multiple types of guns used, second victim self-transported to the hospital with gunshot wounds sustained during the incident, in stable condition, non-life threatening injuries, in addition to the shooting there were multiple cars involved in a collision as a result of the shooting, 4 cars, an additional victim was located suffering from injuries sustained in the traffic collision, in stable condition, investigation ongoing. Shootings: 1st – July 3rd 19:50, 1900 block of Mission, two people were involved in an argument and began shooting each other, striking the victim, the victim was transported in stable condition,

investigation ongoing, no arrests made. 3rd – July 5th 17:00, the unit block of Conklin in the Bayview, victim was sitting in their car when the suspect pulled up, pulled a gun, pointed at the victim, shot one time, and the victim was struck, transported to the hospital and in stable condition, investigation ongoing, no arrests. 5th – July 5th 21:49, 25th and Connecticut Officers responded to the area, located the victim suffering from a gunshot wound, victim was transported in critical but stable condition and at this time has been unable to provide a statement, investigation ongoing. 6th – July 5th, 23:01, unit block of Jones Street, Tenderloin, Officers responded to a 911 call stating that a victim had been shot in the area, victim was seen fleeing from the location, multiple units attempted to locate the victim but were unable to, later a gunshot victim walked into a local hospital but did not provide any information as to how they sustained the injury, although believed to be linked to this shooting, it has not been confirmed, investigation ongoing. 7th – July 5th 23:00, 41st Avenue, 1200 block of 41st Avenue, Taraval, victim was sitting inside of a car, was shot once the witnesses advised that they heard one gunshot and saw three people running from the scene, victim was transported with non-life-threatening injuries, investigation ongoing.

Significant arrest: 2nd shooting- July 4th 14:57, unit block of View Street, Bayview, shooting occurred in which the victim was in an argument and was shot multiple times by the subject, victim was transported in critical condition, the suspect was located and arrested. 4th shooting– July 5th 20:35, Hyde and Ellis, the victim sustained a gunshot wound while in the area of Hyde and Ellis and the Tenderloin district, victim was transported and is in stable condition, non-life-threatening conditions, Officers did an investigation, located the suspect and arrested that suspect. A couple of arrests from previous shootings that resulted in homicides – on June 15th, homicide, on the unit block of Wiese Street in the Mission District, the victim did not survive that shooting, investigation identified the suspect, on July 3rd suspect was located and arrested by SFPD Investigators after a warrant had been issued, evidence was seized during the serving of a search warrant, suspect was booked and charges have been filed. Second arrest on a previous homicide that occurred on April 13th at 6th Street and Jessie, Tenderloin, victim did not survive, Investigators identified a suspect, on July 1st suspect was taken into custody by Officers at 6th and Mission, suspect was booked on multiple charges, including the homicide and was in possession of a loaded firearm when they were taken into custody. A couple of other notable arrests – series of vandalisms to Waymo, autonomous vehicles, 20 in all. On June 26th Waymo reported that at least 20 of their cars had their tires slashed, and they believe it was by the same person, this was between June 24th and June 26th, person was identified using photos provided by the company, subject was located and arrested in the 300 block of Bryant by SFPD officers, case has been solved, suspect was booked into custody on a felony vandalism charge. The last notable arrest was an arrest on an Estes robbery, this occurred on July 1st, an employee attempted to stop a person attempting to flee from a store with multiple items without paying for those items, the subject punched the employee who fell to the ground and kicked the employee in the head, that employee was transported in critical condition and the subject was identified through surveillance videos that were obtained, was located by Investigators and taken into custody, that person was booked on multiple charges of assault, including, assault with a deadly weapon, robbery, and battery with great bodily injury.

Strategies: A lot of events in the past couple of weeks with 4th of July, which was very successful, one shooting, overall a very peaceful night, a lot of fireworks all over the city, and that went in to the morning hours. Pride was successful, had gotten intelligence that there may be protests that might disrupt it, other cities experienced that, but SF did not, very successful event, including the festival and Officers and the public had a good time at those events. This past week, Saturday of this past weekend, the Hill Bomb Event, Officer deployed, were able to prevent the hill bomb on Dolores Street and in the park, but the skaters did skate down Church Street, there were no acts of vandalism

except for one, SFPD van was tagged with graffiti, no assaults on the public, nor officers, two injuries that occurred to skateboarders at about close to 19:00, started skating down Church Street, did not cite or arrest anybody for skating, a lot of public outreach on that, overall it was a huge success, particularly compared to some of what has been in past years, Thanked Officers for their strength that they showed, very well deployed and word was put out on that, SFPD would not tolerate the violence and the property damage seen in the past, wanted to make sure that mainly that community was not destroyed like it had been in past years, went off very well.

Executive Director Henderson reported the following: In the year 2024: 388 cases opened; 476 closed; 137 pending; 34 cases sustained; 20 cases past 270-day; 8 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting)**: 64. Central, 6. Southern, 7. Bayview, 6. Mission, 7. Northern, 7. Park, 1. Richmond, 3. Ingleside, 4. Taraval, 2. Tenderloin, 11. Airport, 1. Not Applicable, 3. Out of Jurisdiction, 2. Pending, 2. Allegation Summary: Neglect of Duty-The officer failed to take required action-17%. Conduct Unbecoming-The officer behaved or spoke inappropriately-17%. Neglect of Duty-The officer failed to properly investigate-6%. Unwarranted Action-The officer engaged in unwarranted action-5%. Neglect of Duty-The officer failed to write an incident report-5%.

Audits: DPA's Audit Division is preparing for peer review coordinated by the Association of Local Government Auditors. DPA's audit of SFPD's processes on stop data is ongoing, goal is to complete fieldwork testing on the stop data audit by the end of July.

Outstanding Issues: DPA's Investigations Division has substantially reduced cases pending over 270 days to one non-tolling case. Investigations: DPA's Investigators and Attorneys attended an SFPD led training on DGO 5.20 (Language Access Services for Limited English Proficient Persons). Policy: DPA completed a comprehensive review of SFPD's Draft DGO 6.10 (Missing Persons).

Outreach: DPA conducted outreach at several Pride events and the SFPD Hill Bomb Town Hall over the past month.


Closed Session disclosure for Item 20(a):
