The Police Commission of the City and County of San Francisco met in Room 400, City Hall, #1 Dr. Carlton B. Goodlett Place, San Francisco at 5:40 p.m.

GENERAL PUBLIC COMMENT

H. Brown: Spoke about diversity within first responders and healthcare workers.

Chris W. Kline: Spoke about a previous public comment he made. Pledged, along with his non profit, to bring peace back to the community, prejudice and violence needs to stop.

Jay Connor B Ortega: Co president of District 3. Thanked members of the department. Welcomed Commissioner Clay. Referenced Commissioner Clay's comments from previous meeting. Provided opinion regarding DGOs and Prop E. Ask Commission to follow law as written.

Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime down 11 percent; homicide down 38 percent; rape down 11 percent; robbery down 18 percent; assault down 3 percent; human trafficking down 30 percent. Property Crimes down 34 percent; burglary down 18 percent; motor vehicle theft down 18 percent; arson down 10 percent; larceny theft down 41 percent. Gun violence is down 29 percent compared to 2023; Four non-fatal shooting incidents this week; total 76 fire-arm related incidents resulting in 86. victims YTD. One homicide for the week; there are a total of 18 homicides YTD with 13 resulting from a firearm; 94% overall clearance.

Significant Incident: Homicide that occurred on Mission between 16th and 17th, 7/9/24 00:17, victim succumbed to his injuries on the scene, another victim was transported in stable condition, there was also multiple vehicle collision at that scene that resulted in at least four vehicles being damaged in that vehicle collision, believe that was as a result of the shooting as well, investigation is still ongoing with no arrests at this time, if anybody has any information please call the SFPD anonymous tip line at 415-575-4444. In terms of shootings, there were four non-fatal shootings this week, resulting in four victims. The first one was on 7/8/24 at Post and Laguna, this was during a carjacking where a victim was shot by two subjects who produced a gun and shot one of the victims, that car was later recovered, but the suspect is still outstanding, investigation is ongoing. On 7/8/24, there was a shooting at the 400 block of Eddy Street, Tenderloin, 03:45, the subject entered the lobby of a residential building, victim, who was the manager of the building, did not recognize the subject and refused to let him enter, the subject then shot the victim and ran away from the location, victim is listed in stable condition with non-life threatening injuries, that investigation is ongoing, no arrests at

this time. The third shooting was on 7/14/24 09:58 on 600 block of O'Farrell in the Tenderloin, the victim was walking in the area when he was struck by a bullet, no further information was obtained by the victim, non-life-threatening injuries, investigation ongoing. On 7/12/24 03:05, Larkin and Olive, Tenderloin, victim was walking when he saw two subjects arguing, victim heard gunshots and returned to his residence, and then later realized he had been shot, he had a gunshot wound, victim was transported, was in stable condition, non-life threatening injuries, and that investigation is still ongoing as well, no arrests at this time. On 7/13/24, Tenderloin officers responded to a suicide, a gentleman, the father of a three-year-old named Ellie Lorenzo, the father committed suicide in San Francisco, SFPD received a request from Fremont Police that his three year old daughter was missing, the three year old's name was Ellie Lorenzo, SFPD assisted with the search since the father was found in SF after he committed suicide, that three year old was later found in the city of San Jose, deceased, as far as the suicide, there was no foul plays suspected at this time, Fremont and San Jose are both handling their respective investigations, the San Francisco connection was the father committed suicide in San Francisco. Couple of ATM robberies, 7/13/24, there were two calls regarding theft of an ATM machine, both inside retail establishments, one on the 400 block of O'Farrell at 04:45, the other on the 800 block of O'Farrell, just minutes later, in both incidents the subjects gained access inside the store and attempted to steal ATM machines, second incident, the machine had been moved, by the time officers got there the suspects had fled and the machine was still on the premises, conducting follow ups, no suspects in custody at this time, the investigation is ongoing. Fatal traffic collision on 7/11/24 00:41, pedestrian was hit by a vehicle at the area of Geneva and Delano, Ingleside, pedestrian was pronounced deceased at the scene and the driver remained at the scene, investigation is ongoing. The last incident - a media report of a sideshow that ended up in an accident or traffic collision, on Market Street, was, actually not the case, SFPD's investigation revealed that it was actually a single vehicle that was doing donuts in the street, driver apparently lost control and drove into the building, so the report that this was as a result of the sideshow, was actually not to be the case, video evidence corroborates what found to be a single vehicle involved in this in this particular incident, investigation is still ongoing, this was not as a result of a sideshow.

Significant arrest: N/A

Strategies: In terms of our sideshow or stunt driving events, there has been a decrease in the amount of those events reported this year to the Police, there was 45 incidents for all of last year, this year there has been 22, seeing a little bit less than this time last year, have impounded some cars, not a lot, that strategy and that tactic will continue.

DPA Director's Report

Executive Director Henderson reported the following: In the year 2024: 397 cases opened; 504 closed; 137 pending; 34 cases sustained; 20 cases past 270-day; 9 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting)**: 15. Central, 2. Southern, 3. Bayview, 2. Mission, 2. Northern, 1. Tenderloin, 3. Airport, 1. Out of Jurisdiction, 1. Allegation Summary: Conduct Unbecoming-The officer behaved or spoke inappropriately-21%. Unwarranted Action-The officer detained a person without reasonable suspicion-13%. Neglect of Duty- The officer

failed to take required action-13%. Neglect of Duty- The officer failed to write an incident report-13%. Neglect of Duty-The officer failed to properly investigate-8%.

Audits: DPA's intent is to close out fieldwork testing by the end of the month. After fieldwork, DPA will hold an exit conference with SFPD and prepare a draft report for their response.

Outstanding Issues: DPA is presenting four cases in closed session tonight, which represent 1/3 of all cases pending before the Commission. DPA attorneys attended a meeting at IAD to discuss how discipline cases move through their respective systems and try to improve efficiency. Met with SFPD on DGO 6.13 (Hate Crimes) to discuss goals for the update and current draft.
