This office represents Mary Lambert, Successor Trustee of the above entitled Trust.

Enclosed please find the following:

Regarding the pending Petition for Instructions on the Humane Society's claim (that they receive a share on behalf of The Ark Trust; The Ark Trust merged with the Humane Society), at the initial hearing on 6/1/2024 the Judge directed the parties to meet and confer to attempt to come to a resolution and the matter was continued to 9/24/2024. Thereafter the matter was continued by the court to 10/16/2024. No beneficiaries other than the Humane Society have come forward with a response to the petition or made a claim. The enclosed revised Distribution Schedule includes a share to The Ark Trust, resulting in all beneficiaries receiving about \$500 less and distribution checks are being mailed to beneficiaries. It would be cost prohibitive to continue litigation in court. Based upon the foregoing, a Request for Dismissal of the pending Petition for Instructions will be filed before the next hearing.

Pursuant to Probate Code Sections 16063(6). Claims against the trustee for breach of trust may not be made after the expiration of three years from the date the beneficiary receives an account or report disclosing facts giving rise to the claim.
