#### **BUSINESS DESCRIPTION**

Shaw Shoes is a high-end Italian footwear store, opened by Shaw Dehghan at 2001 Union Street in October 1970. Shaw Shoes is the oldest retail store and the second oldest business on Union Street in Cow Hollow.

Shaw Shoes has been an important destination for the women of San Francisco to buy unique Italian shoes for their most important work and social events. Shaw Shoes was the first retail store in the United States to carry world renowned shoe designer Giuseppe Zanotti and the first retailer in San Francisco to carry Casadei. Customers come to Shaw Shoes to discover new designers and learn about the latest shoe trends. Most of the shoes at Shaw Shoes are hard to find anywhere else in the United States since they are imported directly by Shaw Shoes. The business imports their merchandise using their own transporters and importers.

Shaw Dehghan has owned the business since its opening in 1970. His daughter, Caroline Patterson, grew up and worked in the store throughout high school and college and was named co-owner in 2011. It is one of the few small businesses that has survived the endless turnover of commercial space on Union Street. Many of the commercial businesses on the street are now formula retail.

- The business is associated with the Italian craft of footwear and accessories.
- The Union Street property was identified by the Neighborhood Commercial Corridors Survey in 2015 as "appears individually significant," although the Planning Department Historic Resource Status remains "B-Unknown/Age Eligible." The Neighborhood Commercial Corridors survey described the building as follows:

This large commercial building is a striking example of Modern design within this NCD zoning district. Distinctive features include and arcaded storefront echoed by the vaulted base of a projecting concrete walkway above. The upper stories feature a loggia at the base and punched lozenge -shaped opening with balconies. A parking garage is located in the basement and subbasement.

- Shaw Shoes has been featured in Footwear News and SFGate, among other publications.
- With regard to racial and social equity, Shaw Shoes is an immigrant- and minority-owned business. The business has been a member of the Union Street Association since its opening. Caroline Patterson is a board member and dedicated her unpaid time to the organization.

#### INTRODUCTION

#### a. Describe the business. What does it sell or provide?

Shaw Shoes sells high-end Italian footwear and accessories. Most of its merchandise is imported directly from Italy. Shaw Shoes personally imports their merchandise using their own transporters and importers.

#### b. Describe whom the business serves.

Shaw Shoes carries women's footwear and serves the fashion-forward person who wants unique shoes. Most of the shoes at Shaw Shoes are hard to find anywhere else in the United States since they are imported directly by Shaw Shoes. The demographics of Shaw Shoes' customers are between 25 to 65 years old. She either lives in San Francisco or has lived in San Francisco as some point in her life and continues to shop at the store.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Unique Italian footwear and accessories.

## CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

a. Provide a short history of the business, including locations and owners.

In 1970, Shaw Dehghan graduated from the University of San Francisco. He represented the first generation in his family to immigrate to the United States from Iran after obtaining a soccer scholarship for college.

Within the first year after graduating, in October 1970, he opened a shoe store on Union Street in a building that was under construction. Dr. Charles Allen Wall was building a six-story building at 2001 Union Street with only two stories completed when Shaw signed the lease and opened Shaw Shoes. Shaw was 26 years old at the time.

Caroline Patterson, Shaw's daughter, grew up in the shoe store. She worked at the store throughout high school and college. After college, she became more involved and began to take over ownership responsibilities including creating Shaw Shoes' ecommerce website. In 2011, Caroline became a co-owner.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1970 to 2011: Shaw Dehghan

2011 to Present: Shaw Dehghan; Caroline Patterson

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

The only time in history the store was closed was during the COVID pandemic's mandatory shutdown. Shaw Shoes closed the exact day they were required to close and reopened on the exact day they were allowed to reopen.

## CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Shaw Shoes is the oldest retail store on Union Street and the second oldest business on Union Street, in Cow Hollow. Perry's opened one year before Shaw Shoes.

Shaw Shoes has been an important destination for the women of San Francisco to buy unique Italian shoes for their most important work and social events. Shaw Shoes was the first retail store in the United States to carry world renowned shoe designer Giuseppe Zanotti and the first retailer in San Francisco to carry Casadei. Customers come to Shaw Shoes to discover new designers and learn about the latest shoe trends.

b. Is the business associated with significant people or events, either now or in the past?

Shaw Shoes has several well-known customers – including authors, actors, musicians, politicians, and others – but they prefer that their customers remain private.

c. How does the business demonstrate its commitment to the community?

Shaw Shoes has been a member of the Union Street Association since it first opened. Caroline Patterson is a board member of the Association and dedicates her unpaid time to the organization.

d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

Shaw Shoes is occasionally featured in the media regarding specialty shoes that are difficult to find elsewhere. Following are some key media references:

e. Has the business ever received any awards, recognition, or political commendations?

Shaw Shoes has not yet received any awards, recognition, or political commendations.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

San Francisco has struggled keeping shoe stores alive. Most major shoe stores have closed in this city. Shaw Shoes hears from customers at least once a month how it is the only shoe store left in San Francisco that carries shoes for all occasions.

Union Street suffers from constant retail store turnover and more recently has seen mom-and-pop storefronts turning over to formula retail stores. Neighbors and tourists come to Cow Hollow for the unique stores. It's becoming harder and harder for them to find these stores. The mom-and-pop stores are what make the neighborhood unique.

## CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

The building at 2001 Union Street, which houses Shaw Shoes, is one of the only brick buildings on Union Street. The building was built by Dr Charles Allen Wall, who was a very prestigious doctor in San Francisco. The building has stayed in his family's ownership.

#### b. In a few words, describe the main business activity you commit to maintaining.

Shaw Shoes is committed to maintaining footwear sales and specializes in unique Italian footwear and accessories.

### c. What is the plan to keep the business open in the long term beyond the current ownership?

Caroline Patterson is the second generation owner of Shaw Shoes. She has no plans to sell the business and hopes to keep Shaw Shoes in the family for generations to come.

#### d. What challenges is the business facing today?

The biggest challenge today is getting more foot traffic onto Union Street. Since the COVID pandemic, Shaw Shoes has seen a dramatic decrease of foot traffic. A major factor is the lack of tourists. Shaw Shoes used to depend on tourists during the summer months when its customers are traveling. Shaw Shoes is no longer seeing tourists during these months.





#### **Racial and Social Equity Analysis**

On July 15<sup>th</sup>, 2020 the San Francisco Historic Preservation Commission adopted <u>Resolution No. 1127</u> centering Preservation Planning on racial and social equity. Understanding the benefits, burdens, and opportunities to advance racial and social equity that proposed Preservation Planning documents provide is part of the Department's Racial and Social Equity Initiative. This is also consistent with the Mayor's Citywide Strategic Initiatives for equity and accountability and with the Office of Racial Equity, which required all Departments to conduct this analysis.
