What is the Accessibility Strategy?

- Comprehensive, five-year strategy to address the diverse transportation needs of people with disabilities
- Goals:
 - Acknowledge all the work that has been done for accessible transportation over the past few decades
 - Deepen our Strategic Plan and REAP commitments to accessibility
 - Adopt a high-level vision of the resources and actions needed to support improved accessibility

Accessibility Strategy: Process & Timeline

- **Phase One: Needs Assessment**
 - Review Existing Studies, Plans, Workshops, Survey Data to Catalogue Needs
 - **Conduct Outreach to Validate/Refine Needs**
- **Phase Two: Goals and Actions**
 - Develop Draft Goals & Actions
 - Refine with Key Staff
 - Conduct Public Outreach to Validate and Refine Goals & Actions
- **Phase Three: Performance Metrics**
 - Share Final Goals & Actions with Key Stakeholders
 - Develop Performance Measures & Tracking

- Details our successes and challenges in ensuring the accessibility of SF's transportation network
- Includes info from rider survey, performance data, feedback from advisory board meetings and ongoing public outreach

What's Next: Accessibility Survey

- Survey takes 3-5 minutes to complete
- Asks you to rank needs from highest priority (1) to lowest, don't have to rank every category
- Helps us prioritize for next five years in light of fiscal constraints
- Available in English, Spanish, Russian, Chinese (simplified & traditional), Vietnamese, and Tagalog
- **Survey open until December 13, 2024**
- Also attending community events with tablets and printed surveys

Response Rates So Far

- Total Responses: 320 (as of 11/8/24)
- ~50 surveys in hand from workshop with Cantonese-speaking seniors
- People with disabilities: 45%
 - 31% have mobility disability
- Older adults: 27%
- Low response rate from Deaf/hard of hearing community and people with cognitive/mental disabilities
- Low response rate from Black/African American, Latino, Middle Eastern/North African communities
