## Influenza A(H5) Real-time PCR

Synonym(s)	Influenza A(H5) PCR
Methodology	Real-time polymerase chain reaction (PCR)
Acceptable Specimen Type(s) for Testing	<ul> <li>Upper respiratory specimens: For individuals that meet clinical and epidemiologic criteria for influenza A(H5) with respiratory illness, 2 specimens should be collected:         <ol> <li>One nasopharyngeal swab</li> <li>A combined nasopharyngeal and oropharyngeal swab (2 swabs combined into one viral transport media vial).</li> </ol> </li> <li>Conjunctiva: For individuals that meet the clinical and epidemiological criteria for influenza A(H5) with conjunctivitis (with or without respiratory symptoms), 2 specimens should be collected:         <ol> <li>Conjunctival swab. Instructions for conjunctival Sample collection can be found under the Additional Collection instruction section.</li> <li>Nasopharyngeal swab</li> </ol> </li> </ul>
Transport / Collection Medium	Specimens should be collected and placed into Universal viral transport media (VTM or UTM) Specimens should be refrigerated at 2-8°C for up to 72hrs. Alternatively ship specimens on dry ice in compliance with DoT and IATA regulations governing Biological Substances, Category B (UN 3373) Monday -Thursday. Specimen can also be sent via courier Monday-Friday 8:00am-5:00pm.
Storage and	Store at 2 – 8°C for up to 73hrs and submit to the laboratory as soon
Preservation of	as possible; otherwise freeze at ≤-70ºC.

Minimum Volume Required	3 mL
