## Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime down 14 percent; homicide down 40 percent; rape down 13 percent; robbery down 23 percent; assault down 4 percent; human trafficking down 41 percent. Property Crimes down 34 percent; burglary down 12 percent; motor vehicle theft down 19 percent; arson down 8 percent; larceny theft down 40 percent. Gun violence is down 26 percent compared to 2023; One non-fatal shooting incident this week; total 110 fire-arm related incidents resulting in 124. victims YTD. No homicides for the week; there are a total of 25 homicides YTD with 18 resulting from a firearm; 88% overall clearance.

**Significant Incident:** No new homicides. Death from August 11<sup>th</sup> incident, the Medical Examiner has ruled as a homicide, happened at Leavenworth and McAllister, suspect punched victim in the head, caused victim to fall to the ground, victim transported and was in hospital from August 11<sup>th</sup> - October 4<sup>th</sup>, when he succumbed to his injuries, investigation ongoing, more to do before charges can be filed. One non-fatal shooting that resulted in injuries of one victim, October 12<sup>th</sup> 21:31, Officers responded to a call of a shooting victim at a residence on the 2600 Block of Arelious Walker Dr, ni information of the shooting was provided to the Officers, no alert from shot spotter, non-life-threatening injuries, victim uncooperative. Union Square, car drove into a Dior Store, 1100 Block of Post Street, October 11<sup>th</sup> 02:42, Officers were in the area patrolling, arrived almost immediately, saw suspects flee, did not pursue due to suspects' reckless driving. Fatal traffic collision, October 15<sup>th</sup> 00:30, motorcyclist veered off of the road and collided into a pole, area of Bush and Stockton, transported to local hospital and succumbed to injuries, still under investigation.

**Significant arrest:** Homicide arrest this weekend from a homicide that occurred earlier this year at 16<sup>th</sup> and Mission, expect charges to be filed. Narcotics Unit arrests, involved trafficking of fentanyl and other narcotics that resulted in two suspects being booked on multiple charges at the San Francisco County Jail.

**Strategies:** Fleet Week was last week, no critical incidents, a lot of people in the city, no Fleet Week related incidents to report on.

Neglect of Duty-The officer failed to write an incident report-6%.


