Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime down 14 percent; homicide down 40 percent; rape down 13 percent; robbery down 23 percent; assault down 3 percent; human trafficking down 44 percent. Property Crimes down 34 percent; burglary down 13 percent; motor vehicle theft down 19 percent; arson down 9 percent; larceny theft down 41 percent. Gun violence is down 23 percent compared to 2023; One non-fatal shooting incident this week; total 108 fire-arm related incidents resulting in 122. victims YTD. No homicides for the week; there are a total of 24 homicides YTD with 18 resulting from a firearm; 86% overall clearance.

Significant Incident: Related to the news article about the files of officers that were sealed, and the Commission question was whether SFPD has any of those cases, SFPD does not have any of those types of cases. Plan on releasing video on vending incident, plan to release body worn camera, the video itself is over an hour long.

Significant arrest: One non-fatal shooting, resulting in two victims being struck by gunfire, 5500 Block of Mission, Ingleside, September 28th, 14:00, two subjects attempted to gain entry into an illegal gambling establishment, an argument broke out and a staff member at the door and the two suspects continued to argue, a gun was brought out and gunfire was exchanged and two of the people sustained gunshot wounds. There was an arrest made. Significant arrest on robbery, armed robbery suspects, September 22nd, 300 Block of Bayshore, Bayview, this was an armed robbery radio call that just occurred, victim stated he was on his electric scooter when unknown suspects approached and surrounded him then stole his scooter, the victim attempted to flee from the suspects, but they followed him, demanded his property while brandishing firearms, and then took his scooter and fled, Officers from the ingleside district, who heard the broadcast of the armed robbery and the description of the suspect, searched the area and located three suspects who matched the descriptions, the subjects were detained and two of them were in possession of concealed and loaded firearms, stolen property taken from the victim was also discovered during this, both of these two individuals were detained and later identified as the suspects that committed the robbery, a 16 year old was arrested for robbery and conspiracy, and the other person was an 18 year old, 18 years old, and he was also arrested for robbery, conspiracy, possession of a firearm, as well as brandishing a firearm and carjacking that was associated with this incident. Significant arrest by the Internet Crimes Against Children Unit, also known as ICAC, in April 2024, SVU and ICAC Unit obtained information that an adult male suspect from San Francisco was in possession of and distributing child sexual assault material, through the course of this investigation, the suspect was identified as a 56 year old man from San Francisco, Albinus Venice, September 12th a joint operation was conducted by SFPD's ICAC unit, the FBI, Homeland Security investigations and the 100 block of Maynard Street, a search warrant was served and Venice was taken into custody without incident, suspect was booked on multiple counts. Another arrest, happened on February 11th, 2024, there was an assault with a deadly weapon on a peace officer, Bayview, when Bayview officers detailed to the stunt driving response unit were at a gas station at the 4200 block of Mission Street, they were towing a vehicle related to a different investigation when they were surrounded by multiple individuals on dirt bikes, one of the dirt bikes and ATVs began circling the gas pumps and driving recklessly, the suspect on the ATV struck and nearly ran over an SFPD officer and purposefully collided into a pedestrian, the suspect fled on a dirt bike driven by a different suspect, who left his ATV at the scene, the pedestrian sustained non-life threatening injuries and was transported for treatment, the Officer also sustained non-life threatening injuries during the investigation, suspect

was identified as a 31 year old San Francisco resident and a warrant was issued for his arrest, the suspect was located and placed under arrest without incident.

Strategies: Bilingual Testing, an ongoing conversation, the city Department of Human Resources has scheduled three days of language proficiency testing for SFPD, Spanish, Tagalog, Chinese, Mandarin, and Cantonese and Russian.


