



Small Business Administration (SBA) Certification Application Upgrades

The SBA will pause all certification applications starting August 1st to implement a planned upgrade across all of SBA's certification systems. The SBA reports that most certified firms will not be impacted by the pause in applications. New or prospective applicants are encouraged to wait to apply after the upgrade, but applications submitted before August 1 will be processed in the order received. Firms needing to renew should receive guidance from their certification program. Certifications impacted include: Women-Owned Small Business (WOSB), Economically Disadvantaged Women-Owned Small Business (EDWOSB), 8(a) Business Development Program, Veteran Small Business Certification (VOSB), Service-Disabled Veteran-Owned Small Business (SDVOSB), and Historically Underutilized Business Zones (HUBZone) Program.

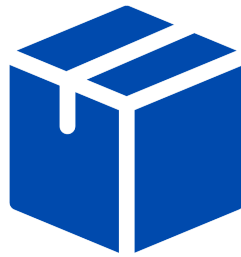

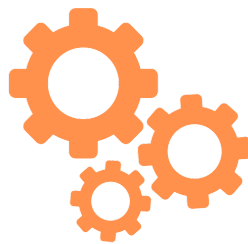
