#### **BUSINESS DESCRIPTION**

Geary Print Shop is a print shop that offers offset printing, digital printing, binding services, graphic design, promotions, and scanning services. The business was established by Matthew Wong in 1978. At the time of opening, it was the first complete print shop and only print shop that offered color printing in the neighborhood.

Throughout the years, other print shops have opened and closed. The business is now the last complete print shop in the neighborhood. Matthew Wong's daughter, Anna Wong Ng, took over the business in 1984. The business continues to serve businesses, government agencies, non-profit organizations, schools, professionals, and other patrons.

#### **Written Historical Narrative**

#### INTRODUCTION

#### a. Describe the business. What does it sell or provide?

Geary Print Shop provides reproduction services in printing, copying, graphic design, and promotional products. They are an experienced group of printers and artists who have been serving the Bay Area since 1978. The business strives for quality, courtesy, and efficiency in their production methods, and they tailor their services to help customers meet their deadlines and budgeting needs.

#### b. Describe whom the business serves.

Geary Print Shop serves the Richmond District general public, businesses, government agencies, non-profit organizations, schools, and professionals.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Printing with quality, courtesy, and efficiency.

## CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

#### a. Provide a short history of the business, including locations and owners.

Geary Print Shop was founded in 1978 at 3452 Geary Blvd. in the Laurel Heights neighborhood near the Inner Richmond district. It was established by Matthew Wong.

In 1984, Matthew was hired by the Alberta Biodiversity Monitoring Institute (ABMI) in their national head office as a manager. He decided to leave the business and concentrate on his new job. Matthew's daughter Anna Wong Ng took over the business.

In 2004, the landlord at 3452 Geary Blvd. passed away. The property management wanted to raise the rent from \$2,400 to \$3,300 per month. Geary Print Shop moved to a lower rent location at 3000 Geary Blvd.

The business moved again in 2019 to its present location at 3236 Geary Blvd because the landlord at 3000 Geary Blvd. decided to sell the property. The landlord would only give a month-to-month lease until she sold the property.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1978 to 1984: Matthew Wong 1984 to Present: Anna Wong Ng

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

Geary Print Shop has never ceased operations in San Francisco since it was founded in 1978. During the COVID pandemic starting March 16, 2020, Geary Print Shop was operated as an online service for six months.

## CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Geary Print Shop was the first complete print shop in the Inner Richmond area in 1978, and at that time it was the only business offering color printing. Five other print shops opened in the neighborhood afterwards, but now they are all out of business. Geary Print Shop is the last remaining complete print shop in the whole Richmond community of 60,000+ people.

The shop offers a range of services for every printing including, but not limited to, the following:

- Offset printing
- Digital printing
- Binding services
- Graphic design
- Promotions
- Scanning

Geary Print Shop supports small businesses, non-profit organizations, government agencies, schools and students, and trade professions with printing.

b. Is the business associated with significant people or events, either now or in the past?

Geary Print Shop made the seal for Gavin Newson when he was the mayor of San Francisco.

During Mayor Ed Lee's time in office, the shop provided emergency printing services when requested by the Mayor's Office and City and County of San Francisco.

The owners of Geary Print Shop have been a family friend of former San Francisco supervisor Carol Ruth Silver since 1978.

#### c. How does the business demonstrate its commitment to the community?

Geary Print Shop donates printing and paper to public schools and some non-profit organizations in the area.

Past hirings include second chance employees, and the business formerly offered a program for newly graduated students.

The owners of the business have served on the Greater Geary Boulevard Merchants & Property Owners Association, the Clement Street Merchants Association Group, and the San Francisco Local Merchant Association.

## d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

The business has been included in the United States Manufacturer annual publication since 1984. The business is also a vendor for the City and County of San Francisco and the California Department of General Services as commercial and retail print shop.

#### e. Has the business ever received any awards, recognition, or political commendations?

Geary Print Shop received recognition awards in many public schools for supporting their printing contributions and donations. The San Francisco Unified School District's early childcare office is located nearby at the end of Cook Street, and Geary Print Shop worked with USD's Sarah Tiu in donating binding equipment, paper, and supplies. In addition, Argonne Elementary School received a copier machine and printing services for their textbooks from Geary Print Shop. At their graduation ceremony, they acknowledge the store for supporting the school. Many public schools received discounted printing and free supplies.

## f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

The business is a local minority woman-owned small business. If it were to close, the neighborhood would not be able to receive printing services locally. Other franchise print shops do not offer oversize scanning, binding, and more on a variety of papers at an affordable price with good customer service and urgent services. In addition, this business is the reserve print shop for City Hall for emergency printing.

## CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

The current location of the business is located on the historic Geary corridor.

#### b. In a few words, describe the main business activity you commit to maintaining.

The shop is committed to helping its customers receive excellent quality and timely printing services with the most economical value. In addition, the shop strives to treat their customers with the utmost respect and courtesy.

## c. What is the plan to keep the business open in the long term beyond the current ownership?

Geary Print Shop plans to apply for government grants and funding until the economy revives. The business owner's son, daughter, and godson are in line to continue the business operation.

#### d. What challenges is the business facing today?

Some challenges include the increase in rent and the loss of income of up to 60% due to other businesses closing down during the COVID pandemic. Further challenges include the ever-rising cost of materials and maintenance technicians moving out of the city due to higher cost of living in San Francisco.





On 11/22/2019 MARIANA ROCHITA filed a Property - Commercial Eviction lawsuit against ANNA WONG D B A GEARY PRINT SHOP, INC. This case was filed in San Francisco County Superior Courts.


Mariana Rochita was the landlord at 3000 Geary Blvd. She was trying to sell the building, and she refused to give Geary Print Shop a lease renewal except offering a month-to-month rental. Geary Print Shop did not agree on rent increases when there was no lease, so they continued paying the old rent, but the landlord refused their rent checks. The landlord then refused to return the deposit or apply it to the rent. After Geary Print Shop found a new location, they settled out of court and moved on.

#### **Racial and Social Equity Analysis**

On July 15<sup>th</sup>, 2020 the San Francisco Historic Preservation Commission adopted <u>Resolution No. 1127</u> centering Preservation Planning on racial and social equity. Understanding the benefits, burdens, and opportunities to advance racial and social equity that proposed Preservation Planning documents provide is part of the Department's Racial and Social Equity Initiative. This is also consistent with the Mayor's Citywide Strategic Initiatives for equity and accountability and with the Office of Racial Equity, which required all Departments to conduct this analysis.
