BUSINESS DESCRIPTION

J's Laundry is a coin-operated laundromat that has been operating in the Mission District since 1986. John Muhawieh is the current owner of the business. His father, Jabra Muhawieh, was the owner of the grocery store across the street, Mission Grocertia, and had the idea of opening a laundromat. Sadly, Jabra passed away during the construction of the laundromat and never got to see the business in operation. John named the business after his father once it was completed.

At 21 years old, John oversaw the completion of the laundromat and has run it ever since. While the business was not always profitable, the laundromat is an essential service for the community. For many years, John worked seven days a week and throughout the night. John's son, Jabra, is named after his grandfather and has been helping the family business since he was eight years old. The Muhawieh family hopes to keep the business within the family and to pass it on to future generations.

INTRODUCTION

a. Describe the business. What does it sell or provide?

J's Laundry has been providing laundry services since 1986. The business model includes coin operated washing and drying clothes, blankets, and towels with plenty of folding tables to fold each load. J's washers are the industry's best machines, and their loyal customers keep coming back because of how well the washers clean their clothes.

b. Describe whom the business serves.

J's Laundry serves the hardworking people who live in the Mission District. The average customer is Latino with families. All these families are good-hearted people who do their best to provide for themselves and their children. In addition to serving the Mission District, J's Landry serves customers from the neighborhoods of Potrero Hill and Noe Valley.

Some long-time customers consider the business to be a staple for the community, as the business provides quality services. As the long-time owner, John Muhawieh meets fantastic people who told him directly how much the business has impacted them directly.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Giant Wascomat washing machines wash & dry coin laundromat.

CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

a. Provide a short history of the business, including locations and owners.

J's Laundry was established on July 1, 1986, at 2951 23rd Street, which is its current location. The founder, John Muhawieh, has been the sole owner of the business since it was established.

J's Laundry was planned by John's father, Jabra Muhawieh. Jabra was born on January 17, 1925, in Ramallah, Palestine. He had the idea to establish a laundromat as he was operating a grocery store directly across the street of the location called Mission Grocertia.

Jabra got the permit approved and hired a contractor to build out the laundromat business. During the middle of construction, Jabra, at just 60 years old, suddenly died in Saint Mary's

Hospital. It wasn't the stroke that killed Jabra, but rather the negligence and critical errors of the hospital after his recovery, as he was supposed to come home that same day.

Jabra's son John was devastated, heartbroken, and struggled to move on.

John was forced to grow up overnight and had to take care of the family business and become a father figure for his siblings. John remembers getting a penalty for a late bill that was sent right after Jabra died. John told the agency that his father had just passed away and kindly asked them to remove the penalty. They didn't care about that and ordered John to pay the hefty penalty with the bill. John was just 21 years old, but he learned quickly how the world worked. He had to deal with multiple agencies and issues after his father's death, but his resilience emerged. He had no choice but to continue what his father started. John went back to work to finish building out the laundromat with no experience and with a problematic contractor.

John eventually finished the project, but the man who had the idea and vision – Jabra Muhawieh – would never see the finished product. This business is very sentimental to John, especially since his father, who started this business, immigrated to the United States from Palestine to create a better life for his family.

J's Laundry was named after Jabra Muhawieh to always remember the man behind everything.

b. Provide the ownership history of the business in a consolidated year-to-year format.

1986 to Present: John Muhawieh

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

Since the business was founded in 1986, J's Laundry has never ceased operations in San Francisco. The business has been there for the entire community and continues to provide quality services seven days a week.

As the owner of the business, John Muhawieh takes pride in maintaining a clean facility and making sure the washing machines, dryers, plumbing, electrical, and changer machine are working every single day.

CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

J's Laundry has been the go-to laundromat for residences of the Mission District and other neighborhoods of San Francisco since 1986. The history of the business stems from the core value of providing quality services at good prices. The small business touch is felt throughout every customer interaction. Over the years, the identity of J's Laundry has been to give customers the best washing and drying experience for each load of laundry.

Many customers continue to make a fun day out of doing laundry, which includes getting a burrito, watching Latino soap operas on the televisions inside the business, and catching up with their families. Countless customers build great connections as they talk about their lives together. The history of J's Laundry has been enriched from the strong work ethic of the hardworking people of the neighborhood.

b. Is the business associated with significant people or events, either now or in the past?

Everyone is a legend to someone in this world. It's very difficult to become famous; however, it's truly other people who continue to tell your legacy.

Jabra Muhawieh, who envisioned the laundromat but died before it opened, is a significant and legendary person to his son John Muhawieh. Jabra accomplished many things in his life. Part of his legacy is J's Laundry, which continues to serve the community in Jabra's honor.

c. How does the business demonstrate its commitment to the community?

J's Laundry has continued to provide quality washing machines and dryers since the beginning. For some years, J's Laundry did not make a lot of money, but owner John Muhawieh continued to run the business without giving up. He was dedicated even though the profits were not there. There were years in which he could have closed J's Laundry, but he truly loves the laundry business. Serving the kind people of his neighborhood was something that made him feel good inside each and every day. Even though running a business is about making a profit, John continued to show the community that he is dedicated to keeping the doors open. With very low profits for some years, it was the spirit of community service, the ability to give back to the community, that drives John to keep the business alive.

In addition to keeping J's Laundry open, John was born in the building directly across the street from J's Laundry. As a young boy, he helped his father run a grocery store called Mission Grocertia and faced many other challenges. John has always been committed to this community from the moment he was born up until the present moment, and he will continue for years to come.

d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

J's Laundry has not been featured in the media.

e. Has the business ever received any awards, recognition, or political commendations?

J's Laundry hasn't received any rewards, recognition, or political commendations. John Muhawieh is hopeful that Legacy Business designation could be the opportunity that J's Laundry deserves to be recognized for the continued positive contribution it has given to the community.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If J's Laundry were to shut down, many neighborhood residents would lose a convenient quality laundromat. In addition, there are no other Wascomat washers in the area, and many customers know the difference between Speed Queen washers and Wascomat ones.

In addition, J's Laundry's loyal customers are what keep the business going because they know how long the current owner has been there. These customers consistently tell the owner John that he should give it to his son to take over the family business because they can sense his time is coming to an end. There are times when long-time customers bring up John's father Jabra in conversation about how he was truly a man of honor and how he took care of them with whatever they needed when they went to his store. They know the history of the business and would be very disappointed if the business didn't stay in the family. John wants to continue to serve the community and hopefully become a Legacy Business.

CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

J's Laundry doesn't have any significant signs or features that define the business.

b. In a few words, describe the main business activity you commit to maintaining.

J's Laundry serves laundry and drying services for all walks of life. The owner, John Muhawieh, is committed to keeping the business open while providing the best possible products or services that serves the community in a positive way.

c. What is the plan to keep the business open in the long term beyond the current ownership?

J's Laundry will hopefully be in the Muhawieh family forever. The sentimental value of the business dates back to when Jabra Muhawieh was building out the business. Once his son John finished the project, he named the business J's laundry in honor of his father.

The goal is to maintain the business as a laundromat and eventually have John's son run the business. John's son Jabra is named after his grandfather, and Jabra is John's right hand man. John knows his father would be happy with this decision, especially since John's son has worked with John since Jabra was eight years old. Jabra has helped John run the business and other businesses since he was a young boy. For example, Jabra worked the night shift during a critical time of J's Laundry, working seven days a week for many years. John knows his dad would be proud that John completed his project and operated J's Laundry since 1986, which was the same year he passed away on March 9. The next generation will continue the elder Jabra's legacy, which will hopefully live on forever.

John hopes that the Legacy Business designation can provide John with the guidance, support, and resources to maintain the business.

d. What challenges is the business facing today?

J's Laundry has faced multiple challenges throughout the years of operation. In the laundry business as the years go by, the machines and dryers start to break down from the wear and tear of running the equipment constantly. When machines break, maintenance is required, which puts a lot of stress on the aging owner.

Another challenge the business faces is declining revenue. After the year 2020 – the initial year of the COVID pandemic – many people have not come back to J's Laundry. Even the most popular Wascomat machines may not attract new customers.

Another challenge is the overall laundry industry as a whole has been declining. One reason is that newly constructed apartment buildings have installed washers and dryers inside the units. These potential customers don't need to come to laundromats anymore because they have laundry services directly in their homes.

A final challenge has been the constant vandalism, breaking of windows, and damages to the equipment from criminals. For example, one intruder severely broke the changer machine twice. The criminal didn't back down even when it was fixed the first time. In addition, the quarter box has been broken into several times with loss of revenue from the business income. Furthermore, another intruder broke the big laundry soap machine, which used to provide several soap and dryer sheet options to customers.

All these challenges have been draining energy and money for many years now. The J's Laundry business journey has been an awesome ride serving the community, and hopefully it will continue despite the challenges.
