BUSINESS DESCRIPTION

Walter Adams Framing is a custom art framing company specializing in archival and conservation framing, shadow boxes, custom framed mirrors, acrylic boxes, and photo frames. The framing store has continuously served the San Francisco Bay Area with the largest selections of custom frames. Ranging from modern minimalism to baroque period reproductions, they are constantly expanding their collection. The Lower Pacific Heights location at 2019B Fillmore Street is a long-time retail establishment providing a multitude of framing services and home items for Fillmore and Lower Pacific Heights neighbors and tourists. Walter Adams is an active member of the Fillmore Merchants Association.

First opened by Jane Walter and Robert Adams at Geary Boulevard and Masonic Street in September 1978. In 1982, they moved to 355 Presidio Avenue in Presidio Heights. In 1992, the company was purchased by Nikita Van Beek and Susan Van Beek. In 2013, the 9th Avenue location closed. In 1999, Nikita and Susan purchased the three "Frame of Mind" frame shops at 2019B Fillmore Street in Lower Pacific Heights, 239 West Portal Avenue in West Portal, and 1262 9th Avenue in the Inner Sunset. In August 2023, Lloyd Haddad and Keith Wicker purchased the businesses. They retained the name Walter Adams Framing and existing locations and continue to operate the business to this day.

Walter Adams Framing has a long-standing relationship with notable designers and decorators throughout the Bay Area. These design firms rely on the expertise and high-quality service and products that Walter Adams provides to fulfill their design vision. Walter Adams Framing offers full solutions for the art and framing process: in-home/business design consultations, frame sample loan program, private consultations, delivery and pickups, and scheduling of hanging framed artwork. Additionally, Walter Adams supports local artists through showing of artwork and framing cost assistance in preparation for art shows. Walter Adams has had ongoing relationships with many prominent San Francisco residents and prominent designers including Joe Montana, the Getty Foundation, Loczi Design, Tracy Simmons Design, and Kendall Wilkinson Design.

INTRODUCTION

a. Describe the business. What does it sell or provide?

Walter Adams Framing is a custom art framing company specializing in archival and conservation framing, shadow boxes, custom framed mirrors, acrylic boxes, and photo frames.

The quality custom framing at Walter Adams Framing is unmatched. The impact of a piece of art can be dramatically affected by the quality of its frame. At Walter Adams Framing, they understand this. They have been providing clients with quality custom picture framing and an unmatched selection of photo frames since 1978. Whether it's a valuable oil painting or an irreplaceable photo of a loved one, Walter Adams Framing has the expertise to give your artwork that perfect, tasteful touch.

Walter Adams was founded in September 1978 by Jane Walter and Robert Adams as an upscale home accessories business located at what is now the City Center shopping center at Geary Blvd. and Masonic Avenue.

In 1982, they moved to 355 Presidio Avenue in Presidio Heights. In 1992, the company was purchased by Nikita Van Beek and Susan Van Beek and changed to Walter Adams Galleries. While not experienced in custom framing, the Van Beeks adapted to start growing the business

and elevating the brand perception throughout the Bay Area. This was accomplished by offering high quality products and exceptional service.

In 1999, Nikita and Susan purchased the three Frame of Mind frame shops at 2019B Fillmore Street in Lower Pacific Heights, 239 West Portal Avenue in West Portal, and 1262 9th Avenue in the Inner Sunset . All three of these locations were then incorporated into the Walter Adams Brand.

In 2013, the 9th Avenue location closed due to company downsizing, leaving the three existing locations.

In 2014, the West Portal shop was moved from 239 West Portal Avenue to 348 West Portal Avenue, where it currently operates.

In August 2023, Lloyd Haddad and Keith Wicker purchased the business and kept all three locations under the Walter Adams Framing name. Both new owners are well respected, veteran framers with combined business experience exceeding 35 years.

There was no closure of this business for a significant duration. Even during the COVID pandemic, the business was closed for only 10 weeks, which is not significant considering the length of the company's existence.

All Walter Adams Framing employees are local to their communities. The Presidio location includes a gallery showcasing a rotating display of framed pieces from local artists.

The Lower Pacific Heights location is a long-time retail establishment providing a multitude of services and home items for Fillmore and Lower Pacific Heights neighbors and tourists. Walter Adams is an active member of the Fillmore Merchants Association (<u>https://fillmorestreetsf.com/shopping/arts-antiques/walter-adams-framing/</u>).

West Portal is the newest location for Walter Adams Framing. The shop serves the neighborhood and shopping district and has a long-term relationship with residents. (Walter Adams Framing is an active member of the West Portal Merchants Association.

e. Has the business ever received any awards, recognition, or political commendations?

Not applicable.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If the business were to close, a void would be created for those residents and businesses in their respective communities and neighborhoods. Walter Adams Framing currently employs nine individuals and contracts work to a handful more that would be negatively impacted were the business to be closed. The impact of relocation and selling of the business would depend on where it was located to and who bought it. When the current owners bought the company, they implemented a number of positive changes for the employees, hired new additional employees, and improved the processes and equipment used by the company.

CRITERION 3: The business is committed to maintaining the physical features or traditions that define the business

a. Is the business associated with a culturally significant building, structure, object, signage, mural, architectural detail, neon sign, or any other special physical feature that defines the business?

The building at 2019-2021 Fillmore Street, while not officially historic, is a contributor to the Eligible Upper Fillmore Neighborhood Commercial Historic District.

Walter Adams Framing is committed to maintaining its current presence in their three respective neighborhoods: Presidio Heights, Lower Pacific Heights, and West Portal.

b. In a few words, describe the main business activity you commit to maintaining.

Walter Adams Framing is committed to providing the highest quality framing services while building and maintaining strong relationships with its clients.

c. What is the plan to keep the business open in the long term beyond the current ownership?

The goal of the new owners is to take the business to the next level of productivity and services. The long-term goal is to acquire a dedicated local workspace so operations processes can be consolidated and streamlined, creating more efficiency and ultimately a better value for its clients. The existing locations, and possibly additional locations, would become almost exclusively design centers and showrooms.

d. What challenges is the business facing today?

Walter Adams Framing currently has relatively reasonable rents it each of its three locations. Additionally, the company has excellent relationships with the respective landlords. There is a concern that if the leased buildings are sold (as they have been in the Fillmore, for example), that new landlords could significantly raise the rents and insurance requirements for the company. This could negatively affect the business in that it may be forced to move or close a location.

There are many requirements that are imposed by the City and County of San Francisco that are expensive and burdensome on small businesses:

- Any graffiti on the business is the business owner's responsibility to remediate otherwise face fines by the City.
- Homelessness in certain areas contributes to the appearance of shopping districts that is a detriment to many small businesses.
- Vandalism puts a huge financial burden on the businesses for repairs and loss prevention. Incidents of vandalism are still high in San Francisco.
- Tree and sidewalk maintenance by the City needs improvement.

Parking enforcement is also an issue in all three locations of Walter Adams Framing. Following are the major topics:

- Commercial spots being used by delivery scooters and non-commercial vehicles blocking use by actual commercially registered vehicles, especially in metered spots.
- Disabled placards on vehicles that are parked for free in metered spots all day in a shopping district make it difficult for clients to park in that district. While this is a privilege extended to those who have valid handicap placards, it should be reviewed for change. There are already designated handicap parking spots which, when violated, carry a large fine. With the advent of app-based pay and park, why should metered spots be free to vehicles with a handicap placard and be allowed to park there all day long for free?

- The price of parking meters in most shopping districts is very high. In businesses like Walter Adams Framing, clients often need upwards of an hour to complete their designs.
- Parklets in San Francisco take up valuable parking spots in most shopping districts. The price paid by the parklet owners does not outweigh the lost revenue to surrounding businesses. Also, this is basically free business square footage without regulation, insurance, increase in rent, etc. that gives an unnecessary advantage to restaurants that have taken advantage of the parklet program. Many of these parklets remain empty and end up collecting garbage and graffiti, and are used regularly for urinals (which impacts the surrounding areas).
- Sidewalk cleaning during non-rainy seasons would be helpful.

a. Features or traditions that define the business and should be maintained for the business to remain on the Legacy Business Registry.

Picture frame store.

b. Other special features of the business location, such as if the property associated with the business is listed on a local, state, or federal historic resources registry.

The Planning Department Historic Resource Status of the building at 345-355 Presidio Avenue is "B - Unknown / Age Eligible." The building "does not appear significant under Criterion C/3 (Architecture/Design)" per a Neighborhood Commercial Corridors Survey (Unadopted) in 2015.

The Planning Department Historic Resource Status of the building at 2019-2021 Fillmore Street is "A - Historic Resource Present." The building is a contributor to the Eligible Upper Fillmore Neighborhood Commercial Historic District, but it is not eligible for listing on the local, state, or national registers per a 2024 evaluation.

The Planning Department Historic Resource Status of the building at 346-350 West Portal Avenue is "B - Unknown / Age Eligible." The building "appears significant as a contributor to an identified cluster" per a 2015 evaluation.







Business Description

Walter Adams Framing is a custom art framing company specializing in archival and conservation framing, shadow boxes, custom framed mirrors, acrylic boxes, and photo frames. The framing store has continuously served the San Francisco Bay Area with the largest selections of custom frames. Ranging from modern minimalism to baroque period reproductions, they are constantly expanding their collection. The Lower Pacific Heights location at 2019 Fillmore Street is a long-time retail establishment providing a multitude of framing services and home items for Fillmore and Lower Pacific Heights neighbors and tourists. Walter Adams is an active member of the Fillmore Merchants Association.

First opened by Jane Walter and Robert Adams at Geary Boulevard and Masonic Street in September 1978. In 1982, they moved to 355 Presidio Avenue in Presidio Heights. In 1992, the company was purchased by Nikita Van Beek and Susan Van Beek. In 2013, the 9th Avenue location closed. In 1999, Nikita and Susan purchased the three "Frame of Mind" frame shops at 2019B Fillmore Street in Lower Pacific Heights, 239 West Portal Avenue in West Portal, and 1262 9th Avenue in the Inner Sunset. In August 2023, Lloyd Haddad and Keith Wicker purchased the businesses and retained the name Walter Adams Framing and existing locations and continues to operate to this day.

Walter Adams Framing has a long-standing relationship with notable designers and decorators throughout the Bay Area. These design firms rely on the expertise and high-quality service and products that Walter Adams provides to fulfill their design vision. Walter Adams Framing offers full solutions for the art and framing process: inhome/business design consultations, frame sample loan program, private consultations, delivery and pickups, and scheduling of hanging framed artwork. Additionally, Walter Adams supports local artists through showing of artwork and framing cost assistance in preparation for art shows. Walter Adams has had ongoing relationships with many prominent San Francisco residents and prominent designers, including Joe Montana, the Getty Foundation, Loczi Design, Tracy Simmons Design, and Kendall Wilkinson Design.

Walter Adams Framing has donated framing to the UCSF Art for AIDS auction, an annual fundraising event for UCSF Healthcare Alliance held each year in September, as well as Creativity Explored, a collective of neurodivergent artists. Walter Adams Framing has also participated in the Decorator's Showcase House that benefits, each year, the San Francisco University High School (located three blocks from the Presidio location).

Staff Analysis

Review Criteria

1. When was business founded?

The business was founded in 1978 and currently has three active locations in San Francisco.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Walter Adams Framing qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

a. Walter Adams Framing has operated continuously in San Francisco for 46 years.



- b. Walter Adams Framing has contributed to the history and identity of the Western Addition neighborhood and San Francisco.
- c. Walter Adams Framing is committed to maintaining the physical features and traditions that define the organization.

3. Is the business associated with a culturally significant art / craft / cuisine / tradition?

Yes. The business is associated with custom art framing, archival and conservation framing, shadow boxes, custom framed mirrors, acrylic box frames, and photo frames.

4. Is the business or its building associated with significant events, persons, and / or architecture?

Yes. The Fillmore Street property is located within the California Register-eligible Upper Fillmore Neighborhood Commercial Historic District. 2019 Fillmore Street is a contributor to the Historic District.

Walter Adams has also had ongoing relationships with many prominent San Francisco residents and prominent designers, including Joe Montana, the Getty Foundation, Loczi Design, Tracy Simmons Design, and Kendall Wilkinson Design.

5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

Yes, the Fillmore Street location is eligible for listing on the California Registry of Historical Resources as a district contributor.

6. Is the business mentioned in a local historic context statement?

No, not as of the date of this Executive Summary.

7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. There have been a number of features and articles on Walter Adams Framing, from publishers including the San Francisco Bay Times and the Nob Hill Gazette.

Racial and Social Equity Analysis

On July 15th, 2020 the San Francisco Historic Preservation Commission adopted <u>Resolution No. 1127</u> centering Preservation Planning on racial and social equity. Understanding the benefits, burdens, and opportunities to advance racial and social equity that proposed Preservation Planning documents provide is part of the Department's Racial and Social Equity Initiative.
