#### **Chief's Report**

- **Weekly crime trends**
- **Major/Significant Incidents**

Assistant Chief David Lazar, on behalf of Chief Scott, reported on crime trends YTD: Violent Crime down 14 percent; homicide down 34 percent; rape down 9 percent; robbery down 22 percent; assault down 5 percent; human trafficking down 41 percent. Property Crimes down 32 percent; burglary down 11 percent; motor vehicle theft down 20 percent; arson down 12 percent; larceny theft down 38 percent. Gun violence is down 26 percent compared to 2023; No non-fatal shooting incidents this week; total 118 fire-arm related incidents resulting in 132 victims YTD. No homicides for the week; there are a total of 31 homicides YTD with 21 resulting from a firearm; 83% overall clearance.

**Significant Incident:** One homicide on 11/13/24 05:36, Market and Main Street, victim located in the middle of the street, San Francisco Fire Department and SFPD on scene, despite attempts at life saving measures victim succumbed to injuries at scene, no arrest, investigation ongoing. One non-fatal shooting, 11/19/24, 1100 block of Hollister, suspect fired at a woman inside a window, woman is pregnant, hit in stomach area, bullet missed fetus, both mom and baby are in stable condition, no arrests made. Officer involved discharge, 11/15/24 10:50, Ellis and Fillmore, Officers responded to three dogs fighting, observed one dog actively attacking a pedestrian, less lethal attempts were used, shortly there after an Officer involved discharge occurred where one of the attacking dogs was fatally struck, within vicinity a second dog was corralled and taken into custody with assistance of Animal Care and Control, a foot pursuit ensued for several blocks attempting to obtain the third dog, during interaction an Officer discharge occurred, Animal Care and Control was able to place the dog into custody, pedestrian was transported with non-life threatening injuries, the dog owner transported their dog to the vet.

**Significant arrest:** Commercial burglary, 10/11/24 02:42, Union Square, suspects drove in and drove off in a high rate of speed, Officers in area observed incident as suspects leaving store, suspects fled scene and were lost in area, based on investigation on 11/1/24 SFPD had probable cause to arrest a 24-year-old suspect on multiple cases. Arrest of a burglary crew, 15<sup>th</sup> and Vermont, 11/7/24 03:00, Bayview Officers responded to a liquor store based on a burglary in progress, broke front gate, stole merchandise and cash then fled, believe vehicle was involved in an earlier burglary in the Mission, Officers attempted to stop vehicle, vehicle drove off at a high rate of speed, vehicle crashed on highway 101 near the 7<sup>th</sup> Street exit, Officers observed the suspect jump off the freeway overpass and land 40 feet down, a firearm and magazine were located near suspect, suspect arrested, linked to other burglaries. In October had a multi-agency effort on Narcotics, included SFPD, Sheriff, DEA, National Guard, conducted investigation on a Narcotics Trafficker selling narcotics in the Tenderloin, had probable cause for search warrant for suspect and vehicle in Oakland, on 11/13/24 observed suspect in Nob Hill area, had foot pursuit, took suspect into custody and executed search warrant in Oakland, seized over 400 grams of narcotics and about \$6,000 in US currency.

**Strategies:** On a monthly basis, SFPD has a Crime Communities Strategies Meeting in Operations, similar to COMPSTAT, all operations command staff and captains discuss strategies regarding overnight vehicles driving into businesses. DMACC (Drug Market Agency Coordination Center) effort in Tenderloin, as of 11/3-11/17/24, have made 54 arrests in Tenderloin, seized 864 grams of narcotics, less overdose deaths reported.

Attorney Jermain Jones, on behalf of Executive Director Henderson, reported the following: In the year 2024: 655 cases opened; 751 closed; 112 pending; 40 cases sustained; 20 cases past 270-day; 17 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting)**: 24. Central, 1. Southern, 5. Bayview, 1. Mission, 2. Northern, 2. Park, 1. Richmond, 2. Ingleside, 1. Taraval, 2. Tenderloin, 2. Airport, 0. Not Applicable, 4. Out of Jurisdiction, 1. Pending, 0. Allegation Summary: Use of Force-The officer used unnecessary or excessive force-13%. Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-13%. Neglect of Duty-The officer failed to properly investigate-12%. Neglect of Duty-The officer failed to properly care for, process, or book property-8%. Unwarranted Action-The officer detained a person without reasonable suspicion-4%.


