## Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime down 14 percent; homicide down 36 percent; rape down 10 percent; robbery down 22 percent; assault down 5 percent; human trafficking down 41 percent. Property Crimes down 33 percent; burglary down 11 percent; motor vehicle theft down 19 percent; arson down 9 percent; larceny theft down 39 percent. Gun violence is down 26 percent compared to 2023; Two non-fatal shooting incidents this week; total 116 fire-arm related incidents resulting in 130. victims YTD. Three homicides for the week; there are a total of 30 homicides YTD with 21 resulting from a firearm; 86% overall clearance.

**Significant Incident:** Three Homicides. 3<sup>rd</sup> homicide, shooting, 10/30/24, 18:11, victim approached by suspect who exited a market on the 400 block of Ellis, victim shot by suspect at close range, suspect fled on foot, Officers assisted victims and search area for suspect, suspect not found, investigation ongoing. Two non-fatal shootings. 1<sup>st</sup> shooting – 10/31/24, 00:52, victim self-transported with gunshot wound, victim advised was walking in area of Leavenworth and O'Farrell when two unknown subjects attempted to rob him, during incident victim was shot, no further information provided, no arrests made, investigation on going. 2<sup>nd</sup> shooting - attempted robbery, on 11/3/24, 01:30, Central District, 400 block of Stockton, victim was at a bus stop when a passenger of a passing car exited and attempted to grab the victim's cell phone, victim fought back at which time victim was shot, victim was transported in stable condition, investigation ongoing, no arrests made. Prevention efforts – attempted burglary at Louis Vuitton 10/28/24, 04:30, numerous cars stopped in front of Louis Vuitton, 200 block of Geary, one car rammed the front door, subjects exited other cars and attempted to enter the store, a Union Square deployed SFPD Officer observed incident taking place and took immediate action, called for backup, multiple suspects fled from police in their cars, short pursuit was terminated due to danger to public, flock cameras monitored, vehicles captured on flock and fled to East Bay, investigation ongoing, one car recovered at scene.

**Significant arrest:** 1st homicide – stabbing, 10/28/24, 13:07, 700 block of O'Farrell, report of stabbing, victim located by Officers, victim transports and did not survive injuries, follow up investigation a suspect was identified and arrested by Officers. 2<sup>nd</sup> homicide – 10/30/24, 16:06, suspicious death, 100 block of 7<sup>th</sup> Street, victim was located unresponsive at a residence, victim was pronounced, suspect was identified and arrested after incident ruled a homicide, investigation ongoing. Juvenile arrested for Lululemon burglary.

**Strategies:** Retail theft operations that resulted in 30 organized retail theft suspects at various locations, in the Taraval 10 suspects arrested, in the Castro District 13 suspects arrested, in the Ingleside 7 suspects arrested. On October 30th, Ingleside Station ran a detail to combat burglaries that have been happening overnight in that district, Taraval, Mission, Park and Northern have all had series of burglaries in the overnight hours, at 02:00 a flock hit from license plate reader was made on a vehicle from a previous burglary, alert went out, Officers spotted vehicle at Stockton and Post, vehicle fled at high rate of speed, unable to catch, prevented burglary from occurring.

### **- Report on recent DPA activities, and announcement**

Attorney Diana Rosenstein, on behalf of Executive Director Henderson, reported the following: In the year 2024: 625 cases opened; 725 closed; 128 pending; 40 cases sustained; 17 cases past 270-day; 16 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting)**: 50. Central, 2. Southern, 4. Bayview, 3. Mission, 5. Northern, 2. Park, 2. Richmond, 0. Ingleside, 2. Taraval, 2. Tenderloin, 10. Airport, 3. Not Applicable, 5. Out of Jurisdiction, 3. Pending, 7. Allegation Summary: Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-18%. Neglect of Duty-The officer failed to take required action-16%. Neglect of Duty-The officer failed to properly investigate-6%. Neglect of Duty-The officer drove improperly-4%. Neglect of Duty-The officer failed to write an incident report-4%.

**Audits:** DPA's Audit Division's exit conference for the stop data audit has been rescheduled to Friday, November 8th.

**Outstanding Issues:** DPA's Policy Division successfully completed the Community Policing and Use of Drones courses offered by the COPS Office at the Department of Justice and has obtained three certifications through the program.
