About 50% of our spending goes to 5 categories of goods and services.




The total amount we purchased in goods & services on behalf of the City in the last fiscal year.

The City's Office of Contract Administration (OCA) is responsible for procuring the goods and services that our City departments need for their day-to-day operations. To fulfill this role, OCA procures long-term contracts for a wide variety of commonly-needed goods and services, as well as conducts procurements for one-time purchases. Currently, OCA holds 583 Term Contracts with a cumulative value of \$2.23B. In the past Fiscal Year, OCA issued 2,240 POs for one-time purchases.
